## MOTION

### ADOPTION OF REPORT OF GOVERNANCE, LABOUR, JUSTICE AND LEGAL AFFAIRS COMMITTEE ON ANNUAL WORKPLAN FOR THE FY 2024/2025 FROM THE DEPARTMENT OF PUBLIC SERVICE AND ADMINISTRATION

**Hon. Pauline Njeri:** Thank you, Madam Speaker. I beg to move the following Motion; -

That, this Assembly adopts a Report of the sectoral Committee on Governance, Labour, Justice and Legal Affairs on annual work plan for the FY 2024/2025 for the department of Public Service and Administration laid on the Table of the Assembly on Tuesday October 1, 2024.

Thank you, Hon. Speaker.

An annual work plan is a blue print on how a department intends to achieve its objectives in line with its functions. A good work plan should comprise of programs to be undertaken, targets, actual allocation, sources of funds, responsible persons and key performance indicators. The Committee did its observations and findings, so the Committee made the following observations in respect of the work plan from the department of Public Service and Administration for the said FY year which is 2024/2025.

Hon. Speaker, areas of compliance; the workplan had a preamble accompanied by department's vision and mission. The department functions were clearly outlined. All the programs to be undertaken by the department were costed with an indicated source of funds. There was an assigned responsible person for every activity stipulated in the work plan. Key performance indicators were included as parameters for measuring outputs on every activity. Expected time frame regarding implementation of programs was provided. Work plan was submitted promptly within the required dates. The County Executive Committee Member (CECM) in preparation of the department's workplan, incorporated recommendations made after scrutiny of a similar document for FY 2023/2024.

However, Madam Speaker there were gaps that were noted and the gaps were three, one, there was no activity making provision for consultative meetings between the public service department and the County Assembly Committee on Governance, Labour, Justice and Legal Affairs.

The second gap Madam Speaker, some activities were not costed such as recruiting five new employees under personnel service sub-program, developing a strategic human resource plan, there was also meetings under leadership and coordination of DAs, industrial relation matters, developing staff welfare were also not well looked into.

The third gap, there was no provision for contingency funds in the budget in case the department was faced with an urgent matter to consider. So, those were the three gaps Madam Speaker, and the recommendations were as follows; -

1. The Chief Executive Committee Member for public service and administration should amend the departments workplan for financial year 2024/2025 and include the following:

-

- i. Provision for consultative meetings between the public service department and the County Assembly Committee on Governance, Labour, Justice and Legal Affairs.
  - ii. Costing some programs, such as recruiting five new employees under personnel services sub-program and developing a strategic human resource plan.
  - iii. Provision for contingency fund in the budget, in case the department was faced with an urgent matter to consider.
2. The CECM Public Service and administration should address the above listed gaps and forward the revised version within 14 days upon the receipt of this Report.

Madam Speaker, the Report was that short and therefore, I call upon one of the Committee members to second. I wish to call Hon. Loise Mbogo to second the Motion.

**Hon. Loise Mbogo:** Thank you, Hon. Speaker. I am a member of the Governance committee; I stand to second this Motion.
