# ADOPTION OF REPORT OF COMMITTEE ON SELECTION ON REVIEW OF NOMINATION OF THE MEMBERS TO THE ASSEMBLY COMMITTEES

Hon. Kibe Wasary: Thank you Mr. Speaker sir, the Committee on Selection establishment and mandate is rooted in Standing Order number 166 with its responsibilities clearly defined by Standing Order 167. The Committee undertook a workshop that took place on 26<sup>th</sup> to 28<sup>th</sup> February 2025. The workshop served as a pivotal moment for scrutinizing the Assembly Committee membership. Mostly the placement was done to consider seven members who had four Committees and we felt that we should be included so that they can have at least five Committees.

Number two, we did new placement of members because Hon. Alex was selected as the chairperson on Delegated County Legislation Committee and initially, he was the vice-chairperson of the Finance Committee and we needed to move a member to the Committee on Finance that is Hon. Edwin Wairagu, who we anticipate will be given the position of the vice chairperson.

Other Committees that we affected include ICT Committee where we added two honorable members; that is Hon. Laban Chomba and Hon. Moses Muchiri. Committee on Public Works we added Hon. Alex Wainaina who we moved from the Finance Committee to the Public, Works Roads and Transport Committee in the same cluster. Committee on Finance we added Hon. Edwin Wairagu and we removed Hon. Alex. The other Committee that was affected was Committee on Powers and Privileges where we added Hon. Jane Mukami. I call Hon. Machigo to second this Motion. Thank you.

**Hon. Charles Machigo**: Thank you Mr. Speaker sir, I am a member of Committee on Selection and is and to second the Motion and I urge the members to adopt the same.

Let us work, let us deliver to the people who really-- you know who really brought us here. By so doing these Committees are supposed to be vibrant. I know they have been vibrant and we have a very vibrant leader of majority. We have a very vibrant, you know whip, we are vibrant leadership. If you cannot beat them, somebody said that you join them. Therefore, we have no choice but to join them so that we have to deliver to the people of Gitugi, I was to say Gitugi but I have realized Gitugi is just a fraction of Murang'a.

Thank you, Hon. Speaker for that. I want to promise that my Committee, leader of majority, my chair and including you, I will deliver to my maximum to my level best. Because I anticipate what the majority said. That 2027 after we deliver, we shall be back here. Some of us, all of us will be back here to continue with delivery of that work.

Last but not least, I am not able to invoke the Standing Orders because I thought it is 135 but I am not sure because I don't have it here. I would say that if we go this way, let us try to, now we are in the laundry machine, our clothes have been washed. We are clean, we are clean as white as snow. That is how it is. But again, also let us try now to keep on streamlining our issues because if you look Hon. Speaker or invite your eyes. They can see how our assembly is very beautiful and you are training and teaching them so tomorrow they will be honourable speakers. The Speaker (Hon. Johnson Mukuha): Thank you, Hon. Wairagu. I had the grace to give you all the time, I don't have the grace to give Hon. Chefman all the time. So can you take three minutes.

**Hon. Chefman Njoroge:** Thank you Hon. Speaker. first and foremost, let me take this opportunity to go to congratulate Hon. Wairagu being a vice chair of the finance docket. So, I know the issue of the mathematics, he will assist our chair there---

**The Speaker (Hon. Johnson Mukuha):** Has he been ratified as the Chair?

**Hon. Chefman Njoroge:** I had him saying so.

The Speaker (Hon. Johnson Mukuha): Get the record straight, he has not been ratified.

**Hon. Chefman Njoroge:** I was also referring to what he has just said in the House on the Floor.

The Speaker (Hon. Johnson Mukuha): So, it is not accurate.

Hon. Chefman Njoroge: I stand guided. First of all is just to support the Committee, and assure members that under the Committee of Selection once and while, in case it is need be, it does what is necessary to do and to make sure the harmony of the Assembly goes around, under the spirit of coming back to home, that is unity and love to each other, I think is a continuous process of doing what is supposed to be done in the right way the manner. As my learned fellow has just said, it is a healing process of where we are coming from, is a way of appreciation and is a way of going through of it.

I really appreciate and ask members it is a continuous process and we shall continue uniting and doing the right thing. However, Mr. Speaker, allow me, if possible, to appreciate and recognize the students from Kambiti ward, whereby they are here to see what we are doing as an Assembly. It is high time, if you allow me Mr. Speaker, to say that they are not children, they are students from a certain secondary school; children is a demeaning word but I think it's good to recognize that they are students of from Kariaini secondary school. It is is a good time for them to come and learn. We'll be having in future years to come, we'll be having good MCAs, we will be having good members of Senate, good governors in future. It is high time they learn and they're learning the right correct way. What and how the Assembly runs and I wish all them the best as they learn. I wish also members of The County Assembly to also be calling some of the students from our area. So, they can understand legislation of our area.

The Speaker (Hon. Johnson Mukuha): Yes Hon. Gachui.

**Hon. Gachui Mungai:** Thank you Hon. Speaker. As I rise to support, I just wanted to inform the House that in commonwealth parliaments, what the Selection Committee has done periodic rotation of membership is very normal so that the members might not be seeing as if it was something sinister when the members were moved. I wanted to set the record straight, it is normally done to enhance the performance of the Committees.

Hon. Clement Gichobe: I rise to support the Motion and I adopt this Report by the Select Committee and Hon. Speaker because this House is guided by Standing Orders. Standing Order 204(4) states that the mandate of the sectoral Committees is in respect of the subject matter under the second schedule of these Standing Orders shall only be exercised within the limits under part two of the fourth schedule of the Constitution. Hon Speaker, if you allow me to quote it verbatim, "The functions of a sectoral Committee shall be a, to investigate, inquire into and report on all matters relating to the mandate, management, activities, administration, operations and estimates of the assigned ministries and departments, b, to study the program and policy objectives of ministries and departments and the effectiveness of their implementation". I do not want to read all of those functions but hon Speaker we can all agree that the efficiency of our

oversight role as an Assembly lies in the work done in the sectoral Committees and therefore, if we do not have functional sectoral Committees, then the oversight work in terms of looking at what the executive is doing in matters policy and budget performance we will become very ineffective if our sectoral Committees are not working.

Therefore, because we are all learning and as the Hon. for Gitugi have stated, we are now half term towards our second half we must ensure as an Assembly we have very functional Committees, of course there is what we have achieved in the first phase but I believe we have a big room for improvement in terms of how we perform our duties in our sectoral Committees.

Number two, it is known not only in this Assembly, but also in the national Assembly that sometime the management of the affairs of the Assembly in terms of lobbying would want to be attached to how members are attached to certain Committees. I think it is up to the leadership, and this one I will speak direct to the majority leader, as he performs his duties, I pray that God gives you wisdom to balance managing affairs of the Assembly while ensuring the sectoral Committees remain functional.

If we kill these Committees as we manage Assembly affairs, we need to ensure there is a balance so that everything moves in order and I think as a majority leader, we have the best we would have gotten and I believe that going into the future God will guide him to ensure our sectoral Committees remain strong and functional.

Lastly, I want to challenge our members, like I have said, there is a lot of work coming up we have issues of CFSP coming up and all these issuers will come to our sectoral Committees, I urge members that if we have dropped the ball anywhere let us pick it up and reignite the fire of the sectoral Committees so that our job as the primary oversight body in the County does not die. Thank you, Mr. Speaker, I support the Motion.

The Speaker (Hon. Johnson Mukuha): Mover you can respond.

Hon. Kibe Wasary: I want to thank Hon. Wairagu, Hon. Chefman, Hon. Gachui. Hon Gichobe, I know and believe with Hon. Wairagu joining the Finance Committee, he will bring more value into the Committee together with Hon. Kibaiya who is our able Chair in the Committee. I know that the Committee will perform very much together with the other members who are in that Committee. Hon. Wairagu has said something about peace and Hon. Speaker, I am for peace, I am for harmony, I am for unity. Hon. Gichobe has insisted on the performance of the sectoral Committee and I can only insist on the same since the business of

this House emanates from the sectoral Committees, so we urge the chairs of various Committees to work with the members assigned to the Committee. Hon Gichobe has prayed a good prayer of wisdom. I can only welcome this prayer and I know through that wisdom which is key and principal according to the book of proverbs, with that wisdom I know together with other leaders we will manage the Assembly in a good way.
