ADOPTION OF REPORT OF COMMITTEE ON APPOINTMENTS ON VETTING OF MARGARET WANJA MBUTHIA TO THE SELECTION PANEL FOR MEMBERS OF THE COUNTY PUBLIC SERVICE BOARD

Hon. Ruiru Bernard: Hon Speaker, I beg to move the following Motion; -

That, pursuant to section 58 (a) of the County Governments Act 2012 and section 9 of the Public Appointments Act of 2017, this Assembly adopts the Report on Committee on Appointments on the vetting of Margaret Wanja Mbuthia, a private sector representative nominated by His Excellency the Governor for appointment to the selection panel for recruitment of members of the County Public Service Board laid on the Table of the Assembly on Tuesday 11th March of 2025.

Thank you, Mr Speaker.

Basically, Mr. Speaker, the Committee on Appointments recently held interviews for members of this selection panel, but we were remaining with one final member who represents the private sector and recently we conducted an interview on the same. It is for that reason that we are here to Table a Motion requesting this House to approve this nominee to join this selection panel, so that they can proceed with their responsibility that is mandated to them.

Therefore, Mr Speaker, in a sitting held on Tuesday, March 4, 2025, the Speaker informed the House that he had received notification from His Excellency the Governor on the nomination of this nominee to represent the private sector selection panel for selecting suitable members of the County Public Service Board.

The Speaker committed the nomination to the Committee on Appointments for approval hearing, reporting to the House within 21 days. Basically, once the Speaker received this nomination from the Governor, it was forwarded to our Committee which is the relevant Committee, and we were tasked to handle this issue and have it Tabled to the House within 21 days, the reason is why we are here.

Our responsibility as the Committee, we focused and ensured that the Committee during its scrutiny confirmed that the Governor complied with all legal provisions for the nomination or other as contemplated under the section 58(a). Basically, we had to ensure that for this nomination to have been done, all the provided laws and regulations were adhered to by the appointing authority: in this case who is His Excellency the Governor.

An advertisement was also made on Wednesday, March 5, specifically on page seven of the Star, where the Clerk of the Assembly invited members of public to attend the approval hearing and also submit memorandum and all that, to ensure that the public participation is also involved. We can confirm that the office of the clerk had not received any memorandum and therefore, the Committee held approval hearing of the nominee on Tuesday 11th which is yesterday from 10 a.m. in the County Assembly boardroom under the oath of section 7 the Public Appointments (County Assemblies Approval) Act of 2017.

Upon conclusion, because I want to be brief, we noted that the nominee demonstrated knowledge of her role in the selection panel and also to the requisite abilities, qualifications and experience to serve in the selection panel. We, therefore, through our interview and engagement with the nominee, the Committee was satisfied that this person is able to handle the responsibility and on behalf of this House, we therefore felt prudent enough to submit their name, for the approval of this great House.

Therefore, having conducted approval hearings of the nominee pursuant to the relevant governing Act, the Committee therefore recommended that the House approves Margaret Wanja Mbuthia, member from the private sector for appointment by His Excellency the Governor to the selection panel for members of the County Public Service Board. This is the panel that is now given the responsibility to interview and also to help with the County get the relevant members of the County Public Service Board and therefore it is our commitment as a Committee to ensure that this County gets the best. The County Public Service Board we all know its role and it is now this panel that will help us to get a stable, an able, a powerful public service board, which in return will empower our workers and it will enable our service delivery as a County. I therefore call upon our able member from the Committee Hon. Kamunyua John to second Motion.
