ADMINISTRATION OF OATH

NOMINATED MEMBER REPRESENTING PERSONS WITH DISABILITY

The Speaker (Hon. Johnson Mukuha): Hon Members, vide an addendum Gazette Notice Vol. CXXIV-No. 192 dated 21st September 2022 on nominated Members of the County Assembly, the Independent Electoral and Boundaries Commission (IEBC) gazetted the nomination of a Member of the County Assembly representing persons with disability.

It is important to note that Standing Order 4 (4) provides that, "Pursuant to Article 74 of the Constitution, no person shall assume or perform any functions of the office before taking and subscribing to the Oath or Affirmation of Office provided for under paragraph three. In this regard, Hon. Members, and in order to adhere to the above provisions of Article 74 of the Constitution of

Kenya, we shall administer Oath/Affirmation of Office to Esther Nyawira Kamindo, the nominated Member representing persons with disability.

Hon. Members, for us to undertake the Administration of Oath, Standing Order 4 (2) (b) provides that the Clerk shall lay a list of names of the persons elected and nominated as Members, on the Table of the Assembly. I hereby direct the Clerk to lay on the Table of the Assembly, the addendum Gazette Notice Vol. CXXIV-No. 192 dated 21st September 2022 on Nominated Members of the County Assembly.

(The Clerk laid the document on the Table)

Hon. Members Standing Order 4 (2) (7) provides that, when a Member first attends, to take his or her seat after the first sitting of the Assembly, the Member shall, before taking his or her seat be escorted to the Table by two Members and be presented by them to the Speaker who shall then administer to the Member the Oath or Affirmation of Office. After taking Oath or Affirmation of Office, she shall proceed to subscribe to the Oath or Affirmation of office by signing the Oath or Affirmation of Office. Pursuant to Section 37 of the Leadership and Integrity Act No.19 of 2012, she shall also be required to subscribe to the code of conduct for state officers and the specific code for members of the County Assembly.

In view of the above Hon. Members, I direct that two Hon. Members find the said Esther Nyawira Kamindo and escort her to the podium where they shall present her to me for administration of Oath or affirmation of Office.
