NOTICE OF MOTION

ESTABLISHMENT OF A CANCER REGISTRY AND ROLL OUT OF CANCER SUPPORT PROGRAMMES

Hon. James Kagoni: Aware that County Health services are devolved functions to the county governments as stipulated in part 2 of the Fourth schedule of the Constitution of Kenya 2010, cognizant of the fact that cancer has become a killer disease worldwide, further alive to the fact that our county is greatly affected by the disease

(Hon. Joseph Njoroge rose on a point of order)

Hon. Joseph Njoroge: I have heard from the Clerk that the notice is to be given by Hon. Catherine Wairimu Mugo and Hon. Kagoni did not say who gave him the authority to move the motion.

Hon. James Kagoni: Thank you Madam Speaker, I wish to give the following notice of motion on behalf of Hon. Catherine Mugo,

Aware, that County Health services is a devolved function of the county government as stipulated in part 2 of the Fourth schedule of the Constitution of Kenya 2010, cognizant of the fact that cancer has become a killer disease worldwide, further alive to the fact that our county is also greatly affected by the disease; this Assembly urges the County Executive in charge of Health Services;

- a. To establish a cancer registry to allow for streamlined data management in rates of infections and trends over time data, which can be used to inform cancer control strategies.
- b. To roll out cancer support programmes to sensitize the people on how to adopt a healthy lifestyle to prevent cancer risk and enable early detection.
- c. To provide accurate data on the number of cancer patients in the county and those who die out of the cancer menace
