THE MURANG'A COUNTY APPROPRIATION BILL NO.3 OF 2016- FIRST READING

(The Bill was read the First Time)

APPROPRIATION BILL NO.3 OF 2016 – SECOND READING

Hon. Joseph Muchina: Thank you Mr Speaker, I want to move that;-

The Murang'a County Appropriation Bill No. 3 of 2016 be read the second time.

What is before us today is a replica of the report we passed here last week. When we were looking at the budget for this financial year comparing with the budgets of the previous years, we saw that there was inequity in resource distribution across the county.

For the first time, we were expecting that the issue of inequity will be addressed if the budget we are passing is properly implemented.

The Appropriation Bill which we are discussing today which I hope we are going to pass, we are expecting as we have distributed money in all votes, we expect that the money should be distributed equally in all wards so that the impact of devolution can be felt across the county.

Mr. Speaker I do believe that this budget as it was submitted to this House it was not for crafting any political line up but it is purely for implementing the wishes of people of Murang'a county.

I do not have much on this document but I hope that the implementers of this budget will be serious this time round to implement it as we have passed it, because we had seen a scenario that what we had budgeted for in the previous budgets many of the programs were not implemented.

With those few remarks I would call Hon. Machiri to second the Appropriation Bill.
