Hon. Sarah Njoroge: Thank you Mr. Speaker, I stand to give notice to the following Motion;

Aware that crop and animal husbandry is a devolved function as provided in Part 2(1) of the Fourth schedule of the Constitution of Kenya, 2010, further aware that the National Agricultural Policy emphasizes on diversification to improve farmers yields, recognizing that the Kenya National Agricultural Sector Extension Policy 2012 seeks to promote high value animal husbandry, concerned that most farmers in the County practice small scale farming due to small land sizes, cognizant of the fact that goat milk has high nutritional qualities and fetches high prices in the market, noting that goat rearing can succeed in the dry areas due to the limited amount of feeds required compared to other livestock; this House urges the County Executive Committee Member in charge of Agriculture to initiate a goat milk rearing program in Murang'a County and offer extension, value addition and marketing support services to the programs.

#### FORMATION OF AN INDUSTRIALIZATION POLICY

Hon. Jecinta Ng'ang'a: Thank you Mr. Speaker, I beg to give notice to the following Motion;

Aware that industrial development is one of the four pillars of the National Government, further aware that the National Industrialization Policy Framework's 2012-2030 mission is to promote and sustain a vibrant, globally competitive and diversified industrial sector for generation of wealth and employment through the creation of an enabling environment, cognizant of the fact that most of the industries in Murang'a County produce semi-finished products which are exported as raw materials and do not fetch optimum prices, recognizing the need to consolidate Government services and incentives to attract investors; this House urges the County Executive Committee Member in charge of Trade and Industrialization to;

1. Establish an industrial park in the County to act as the production, value addition and marketing centre in the County.

2. Formulate a County industrialization Policy that encompasses all stakeholders. Thank you Mr. Speaker Sir.
