NOTICES OF MOTION

FORMULATION OF POLICY ON STREET LIGHTING IN URBAN CENTRES

Hon. Sospeter Nyoko: Thank you Mr. Speaker. I beg to give notice of the following Motion;

Aware that County transport which includes street lighting is devolved function as stipulated in part two of the Fourth Schedule of the Constitution of Kenya 2010, further aware that most streets and floodlights in shopping centres in Murang'a County has malfunctioned leading to high cases of insecurity experienced at night through mugging of residents and break-ins of various premises, recognizing that this has been caused by lack of maintenance of street and flood lighting systems in this urban centres and lack of proper fitting of security lighting systems on various premises, this House urges the County Executive Member for Transport and Infrastructure to develop a policy providing that;

- a) All business premises are installed with operational street lights.

- b) Street lighting be a condition precedent to issuance of trade licence.
- c) Street lighting unit be established to install and maintain street lights in all parts of the county.

FORMULATION OF A POLICY ON REGULAR INSPECTION OF ACCESS ROADS IN SHOPPING CENTERS

Hon. Sospeter Nyoko: Thank you Mr. Speaker I wish to give notice of Motion;-

Aware, that County transport which includes County roads is a devolved function as stipulated in part 2 of the Fourth Schedule of the Constitution of Kenya, 2010, further aware that most access roads in shopping centres of Murang'a County are in a dilapidated condition manifesting itself through pot holes and poor drainage systems, recognizing the fact that this has been caused by lack of periodic maintenance of these access roads; this House urges the County Executive Member for Transport and Infrastructure to develop a policy providing that;

- a. Regular inspection of access roads serving all the County shopping centres be conducted to determine their condition;
- b. Periodic maintenance and rehabilitation of the said access roads be informed by the regular inspection be conducted to enhance accessibility.
