**REPORT ON A PETITION REGARDING LACK OF CLASSROOMS AT WANJENGI ECDE
CENTRE IN WANGU WARD.**

Hon. Naomi Maina: Thank you Mr. Speaker, I beg to lay the following Report; -

That, pursuant to Standing Order 216, the Report of the sectoral Committee on Education and Child Welfare, Research, Information and Technology on Petition regarding lack of classroom at Wanjengi Early Childhood Development Education (ECDE) centre in Wangu ward be laid on the Table of the Assembly today Wednesday, March 01 2023.

Mr. Speaker, I seek your leave as contemplated under Standing Order 216 to highlight on some of the issues regarding to the Petition. On February 5, 2020, the County Assembly of Murang'a through the Clerk received a Petition from 30 community members, the petitioners from Wanjengi sub-location in Wangu location, Kiharu constituency regarding inadequate ECDE classrooms at Wanjengi ECDE centre. The grounds for the Petition are as outlined; -

1. That Wanjengi ECDE has only one classroom both for PP1 and PP2 pupils.
2. That both classrooms are only separated by a plywood.
3. That the ECDE centre has no kitchen to prepare lunch for the pupils.

On February 6, 2020, the Petition was Tabled in the County Assembly as a Communication from the Chair and committed to the Committee on Education and Child Welfare. However, due to emergence of COVID-19 pandemic the Education Committee in the second Assembly was unable to complete the task and sought the leave of the Speaker of the Assembly for the extension of time.

In the course of compiling this Report, the Committee met with the Member of the County Assembly for Wangu ward, Hon. Margaret Wanjiku Gichia, the County Executive Committee Member (CECM) and also undertook a fact- finding visit to the ECDE and we met the petitioners.

The Committee made the following findings regarding to the Petition;

1. That, pursuant to Article 185 of the Constitution of Kenya, construction management and maintenance for pre-primary education, village polytechnics, home craft centres, child facilities are devolved functions.
2. That, at the moment the temporary PP1 classroom at Wanjengi ECDE is not conducive for the PP1 learners.
3. That, learners at Wanjengi ECDE share toilets and other sanitary facilities with Wanjengi primary school pupils.
4. That, currently, parents contribute cash for feeding program of ECDE learners with porridge and lunch.
5. That, there is ample land for the construction of two classrooms and playing area for the ECDE learners.

The following were considered as the recommendations by the Education Committee;

1. That, the Executive Committee Member for the Education, IT and Technical immediately allocates funds for the construction of an extra classroom for the PP1 and PP2 learners at the Wanjengi ECDE centre.
2. That, the CECM Education immediately allocates funds for the construction of kitchen of Wanjengi ECDE to enable the provision of hot meals to the learners.
3. That, immediately the CEC Murang'a to provide 5000 litres water tank, four washing basins at Wanjengi ECDE centre.
4. That, County Government of Murang'a immediately provides the learners of Wanjengi ECDE with learning materials, mattresses, table and chairs.

Thank you, Mr. Speaker.

The Temporary Speaker (Hon. Kamwaga Mwangi): Honourable Members, pursuant to Standing Order 216 (2), whenever a Petition is committed to a sectoral Committee, the Committee is required to respond to the petitioner by way of a Report addressed to the petitioner or petitioners and laid on the Table of the Assembly and no debate in relation to the Report shall be allowed.

The Speaker may however allow comments or observations in regards to the Petition for not more than 20 minutes. In view of this Hon. Members, I will allow Members to make a few comments on the Report laid on the Table of the Assembly this afternoon. The Floor is open for comments. Yes, Hon. Kibaiya,

Hon. John Ngugi: Thank you Mr. Speaker sir, I rise to fault the recommendations of the Education Committee on this matter, not in bad faith, but the general overview in the County and especially on matters pertaining most ECDE classrooms is deplorable. In every one of our wards. From what I gather from the good lady from Ruchu ward, is that the students are already housed somewhere and they have toilets though they are sharing toilets with the primary school. That is the case with most of the ECDE classrooms. We have a cure for that in our community projects. The Executive gave a recommendation that the monies that were extended to us as Members of the County Assemblies be used to refurbish or to construct new classrooms in our areas of jurisdiction, and that's the cure for these problems.

We cannot be citing one school in a certain area, whereas the problem that we have extends to every corner of this County. That would be favouritism. I urge caution on matters such as this because in most instances, matters such as this should be guided by a policy and not a knee jack reaction. I understand clearly the need to refurbish, to build, and to furnish our antiquated education system particularly the ECDE which are devolved to Counties. But, I vehemently refuse to go on that road because every other week there will be petitioners from all the corners of this County. Mr. Speaker sir, with humility, with humbleness, with understanding I refuse to be a party to that Petition. Thank you.

The Temporary Speaker (Hon. Kamwaga Mwangi): Hon. Munga from Murarandia.

Hon. Peter Munga: Mr. Speaker, allow me to differ a little bit with my elder brother Hon. Kibaiya, who has said or rather we should not go on the direction of the Petition. But Mr. Speaker if you can see from the documentation, this Petition was February 2020. And according to the rules the Petition must be addressed. And you have said it well that now we have a cure, so this is not a Petition that has come after you are given community projects, it is a prior Petition that is why we are handling it.

Mr. Speaker, regarding the matter on the Report that we went to Wanjengi primary school, the condition is very much wanting and it reflects on the majority of our ECDEs in our various wards, then I urge Hon. Members and the Executive to fast-track on the projects, on the community

-based projects on the ECDE construction and renovation, because the moment you were there, if you are a Member you could even cry, you could even shed tears on the condition of those classes and how children are being taught within one class.

I thank the Executive and the Governor, that now we have projects, we are able change or cure as my brother said. Thank you.

MOTION

NOTING THE CONTENTS OF A MEMORANDA OF UNDERSTANDING ON ACADEMIC CO-OPERATION.

Hon. Kibe Wasary: Hon. Speaker, I beg to move the following Motion;-

That, this Assembly notes the content of a Memoranda Of Understanding (MOU) on academic co-operation signed between the County Government of Murang'a, Elimu International Connection and the following Canadian Colleges and Universities laid on the Table of the Assembly.

- 1) British Columbia Institute of Technology.
- 2) North Island College Courtenay, British Columbia, Canada.
- 3) Thompson Rivers University, British Columbia, Canada.
- 4) Fanshawe College.
- 5) Northern lights College.

Hon. Speaker, Murang'a County Government has geared its efforts towards youth empowerment and also the promotion of education in the County and internationally, for this purpose Honourable Speaker, His Excellency the Governor together with several members who include Hon. Kibaiya, Hon. Grace City, Hon. Gathee Wa Njeri and Hon. Jane Mukami made a visit in the month of November 2022, to Canada, to visit some of these colleges and universities to witness the signing of the MOU with these universities.

We have the document with us that details the contents of the MOU; the first one being the MOU between British Columbia Institute of Technology (BCIT) with Murang'a County Government and it is worth to note that BCIT is a public university. Number two, we have the memorandum of understanding on academic co-operation between the North Ireland college and the County Government of Murang'a and also it is good to note that it is also a public college. Honourable Speaker, mostly the contents of the MOU have the commencement dates of the MOU, the terms of the period and also how the MOU can be terminated.

We also have Thomson's River university, British Columbia Canada MOU and County Government of Murang'a, it is worth noting it is also a public university. We also have the MOU for educational collaboration between Fanshawe college and the County Government of Murang'a under Elimu international educational connection. It is good to note that Elimu international is an agent that will play a vital role as we are taking our youth to Canada for these noble courses that they will be undertaking.

We also have a memorandum of understanding for educational collaboration between the Northlights college and the County Government of Murang'a, also a public university. Hon. Speaker, this exercise started sometimes back and as for now we have 47 registered youth who are interested in travelling to Finland for these courses and we have 81 youth who are interested in travelling to Canada to undertake the various courses.

I urge the Honourable Members of this House to support this Motion as we note the contents of the MOU between the various universities and the Murang'a County Government and I request Hon. Kibaiya to second the Motion.

Hon. John Ngugi: Thank you Mr. Speaker sir, I rise to support this Motion. Indeed, this is a great opportunity for our children to go far and wide in order to get knowledge. Members, as you can recall, the most proficient educated and far looking men and women have come from this County. We remember of Dr. Julius Gikonyo Kiano who is the first PhD holder in East and Central

Africa, and he got his PhD 1956. That journey that he travelled so many years ago is the journey that we want our children to travel in the information age.

Indeed, we were in Canada with the group highlighted by our Majority leader and we were present when all these Memoranda of understanding were being signed. This is a great opportunity for our kids and Members we should note carefully that this is an empowerment programme; this is not a scholarship so I want to beseech Members as they go out there and popularize this programme, they should be clear that the kids that we are taking to Canada are paying their own school fees, their medical bills and their upkeep. The brighter side of this is that even when these kids reach Canada, they will be able to obtain good paying jobs that will even enable them to finance their own education.

I urge Members to support this Motion knowing that for those who are fortunate enough to take the courageous step to move out of this country and go to a foreign country, that they will leave a space for somebody who may be cannot be able to afford to go to Canada. It is a good thing for this County and I personally want to thank our Governor Irungu Kang'ata because these programmes have been around for some time, other counties have been participating in these programmes and we were shocked with our team to find out that counties like Elgeyo Marakwet, a very dry place, there are fights all the time, war, cattle rustling and what have you, those guys have been able to send a substantial number of children to Canadian universities. I just wonder how in 10 years that County will be, because those children are now remitting funds to their parents and supporting them financially and they have only been there for two years. I wonder how in 10 years that County will be.

A County like Murang'a which is a pioneer in education should have taken this path long time, but we appreciate that the Governor came, so we were dislocated from what we used to be and now we are trying to mend ourselves and be the leaders in this country as Murang'a has always been. I rise to second and support this Motion. Thank you very much.

(Question proposed)

Hon. John Munyua: Thank you Mr. Speaker, I rise to support the Motion though with few issues that I would like to note. This document must be taken to the relevant Committee that is on education, we see the way forward about it. There have been challenges here and there, people

have left this country for greener pastures and when they find problems, maybe I wish it will not happen, they will start to say that Murang'a County government should ensure they are safely back. So, we need to have a policy and to have guidelines on this facilitation, I understand my colleague here has said, the County is just a facilitator, it is just a conduit to take them there. So, we see the way forward and how we are committed. As a Committee go and explore what is in these memoranda because we have not go through them. I support because we support the government and their policies and we are here to enable them to deliver to our people. Thank you.

Hon. Grace Nduta: Thank you Hon. Speaker, I rise to support the Motion, having been one of the Members who travelled to Canada for that cause. Just like my colleague from Gatanga ward have said, Murang'a County is known to produce very educated people in the past and is known to have produced great minds in this Republic who hold very big positions, and are known to be very wise even as we sit today. Therefore, I would encourage Members to keep on encouraging members of the public from our respective wards to register for this course and send their children to Canada for further studies.

When we were there, we realized that there were so many opportunities for jobs and all of us know that Kenya has unemployment issues and those are issues that we are experiencing every day as elected Members. So, if we can send quite a good number there, we will know inside that we have created jobs for them and we will also have spaces for those we have left here and in a few years, we will have regained the lost glory of Murang'a County. Thank you, Mr. Speaker, I support.

The Temporary Speaker (Hon. Kamwaga Mwangi): Hon. Kabera, Kamahuha

Hon. Kabera James: One of the things which I put more effort is about education and when this Motion come to this House, I do not see the reason why we should not support. Yes, I agree we have some issues here and there but as we progress, we are going to address these issues which might affect those who will be going to overseas country. Thank you as I support.

Hon. Warisper Elizabeth: Thank you Hon. Speaker, and I rise to support the Motion, I wish to let the Members know that each and every one is here because of the education he underwent. And one, I have been supporting education even before I was elected as a Member of this Country Assembly. I have some members who are overseas supporting my pupils in my area. On this, I sincerely support even by popularizing this programme to my ward, but I have something to Table here on the same, and asking for my Honourable Member for Gaichanjiru who really want

to further his education. Can he be allowed to attend education overseas because we are very many here who would love to go overseas and be given study leave for such. Thank you.

Hon. Chefman Njoroge: Thank you Mr. Speaker sir, I rise to support the Motion but with the reservation of some of the things I think need to be improved in the same. One, Murang'a is known for education and as an economic powerhouse and other stuff through education. I think it is the high time also when any memorandum is done through the executive to be shared prior, so that we can be able also to scrutinize and assist the executive in terms of improvement.

Sometimes you find that you have a difficult time on the ground when people are asking what is this issue of people going to Canada, Finland and all that stuff and you as a Member you do not have full information despite knowing that there is a memorandum that was signed, people are supposed to go there and all that stuff. As much as I support and I am willing, I think the document should be shared with Committee on Education so that we have a preview or a follow-up to know exactly this Memorandum of Understanding (MOU) between the Murang'a County Government and those universities, what it pertains in the same. I do support the Governor in terms of trying to make sure our students are having better education outside and getting also the privileges of employment there.

I think we also need know the kind of courses they are learning there so that they can match with globalization of industrialization and helping us here in Murang'a County so that we do not lose a generation when they learn courses not found in Kenya and then they end up living in those countries of Canada and Finland, and they are not able to come here. So, I think we need to also pertain programs which are more less the same that we are educating them. They will get education, despite also doing the job. During their retirement when they come back home here, again they continue assisting us in terms of developing our country. We should not be just stuck in a country of development. You can see countries like India. We were at par with India and Singapore, but because they pushed themselves in terms of education, they pushed themselves into issue of being an industrial country, they have left us.

So, I think my good friend, under the memorandum, we need to push the studies, we need to know our students whatever they are doing or what they are going to learn there. They can come back home and assist us in terms of again educating our youth or even our institution here. I will also prefer because we have the Murang'a College of Technology, if also we can have a partnership with the University of Finland, Canada, partnering also with the one public university in Murang'a.

So that if we can have a partnership in terms of not only our students going there but even if it is a satellite kind of education among our students who cannot have the fare, they cannot have the medical equipment to go there so that at least it is easy because nowadays the world is a global village.

So, I think as I support the Motion, it can be improved if also those MOU can be shared to our Committee of Education so that even us Members can visit our Committees and, you know, put more of what we know so that it can assist and we make sure that our Murang'a students, whenever they go there, they are safe and secure. We do not want to hear again the issue of they have gone there to get the education, they have gone to learn and then we start hearing about criminal activities because somebody went there, instead of learning, he went ... we need to have also a systematically follow up in terms of our students who are going. Kindly, I have heard our Majority Leader saying they are 80 and all other stuff, but also we need to know who are they, where they are coming from so that even if you pay a visit there, you are able to know you have your own person there and we liaise also with our diplomatic embassies wherever they are.

So, I rise to support it but with a preservation that we need the document to be shared with the Committee on Education so that we can follow up and chip in and we support our Governor for any effort he is doing to improve our Murang'a County. I rise to support. Thank you.

The Temporary Speaker (Hon. Kamwaga Mwangi): Hon. Chairperson for Education.

Hon. Naomi Maina: Thank you Mr. Speaker, I rise to support this Motion. Allow me to say that we appreciate the good work done by the Murang'a County Government and we also applaud this well thought initiative of taking care of our kids who are going abroad to have education. Allow me to also report that, at the Education Committee where I stand, we received the Report last meeting. So, we are going to scrutiny and also give the follow up which is supposed to be done. I support. Thank you.

The Temporary Speaker (Hon. Kamwaga Mwangi): Hon. Priscilla.

Hon. Priscilla Mwangi: Thank you Mr. Speaker, I also support this Motion that our children will be going abroad, they will be having opportunities out there, but I also support Chefman in another way, *ya kwamba* (that) we need to follow up these children.

The Temporary Speaker (Hon. Kamwaga Mwangi): Hon. Member, stick to one language.

Hon. Priscilla Mwangi: Okay.

(Hon. Warisper Elizabeth rose on a point of order)

Hon. Warisper Elizabeth: It is point of order. For sure, we have not yet been provided with the Standing Orders but I am standing on a point of order that Hon. Priscilla cannot mix two languages when ...

The Temporary Speaker (Hon. Kamwaga Mwangi): Hon. Member, noted. Thank you.

Hon. Warisper Elizabeth: Thank you.

The Temporary Speaker (Hon. Kamwaga Mwangi): Continue.

Hon. Priscilla Mwangi: *Ahsante sana* (Thank you very much) it is also good to, *ni vizuri kujua hii lugha ilikuja na wazungu wacha nitumie Kiswahili* (it is good to know this language that came with the English, let me use Kiswahili)

The Temporary Speaker (Hon. Kamwaga Mwangi): Hon. Member, you stick to one language as the Hon. Member has said, and you can continue then in Kiswahili as you suggest.

Hon. Priscilla Mwangi: *Ahsante sana* (Thank you) Mr. Speaker. *Nimesimama ku* (I rise to) support *hii mswada ya kwamba watoto wetu waweze kwenda ng'ambo*. (This motion to have our children go abroad) *Na tunashukuru ya kwamba hio ni nafasi wataweza kusaidika zaidi* (we appreciate because it is an opportunity that will benefit them). *Lakini, nataka kuunga mkono* (But I want to support) Hon. *Chefman ya kwamba tuweze kufuatilia wale watoto tujue wanaenda kufanya nini* (we follow up to find out what they are going to do). *Tunajua ya kwamba katika enzi tunazoishi ni kwamba mambo imeharibika kule* (we know in this era; things have become bad there). *Unaeza peleka mtoto wako kule, tupeleke watoto wetu kutoka Murang'a, wasichana, vijana, waende wakaolewe huko* (We can take our children, and they go get married there). *Vijana wanaolewa na wanaume huko na wasichana wanaolewa na wamama kule. Kwa hivyo, tutakuwa tumeharibu kizazi chetu cha Murang'a*. (Young men are getting married to men, and young women to women, so we have spoilt a whole generation of Murang'a)

Na Kwa hivyo, hata kama kuna nafasi ile, ni vizuri sana kuangalia na kufuatilia wale watoto wanaenda wapi (even if the opportunity is there, let us find out where it is they are going) *Kama sasa tumeona ya kwamba wanajilipia kila kitu, ambapo mtoto ataenda auziwe ng'ombe, auziwe shamba, sababu wazazi wetu watauza hata mashamba ili watoto wao waweze kwenda ng'ambo* (We have seen that they are catering for all their costs, our parents will sell land, their animals, for their children to study abroad) *Yule mtoto akifika kule, hana namna ya kuishi, hana*

chakula, hana nini, atafanya nini? Kijana atapata mwanaume mwenzake amwambie njoo tuishi na wewe. Msichana atapata mwanamke mwenzake, njoo nikuo. Sasa tutakua ya kwamba vijana wetu ambao ni wachache, mnajua tuko na issue ya vijana katika Kaunti yetu, ya kwamba vijana wetu, one thing, hakuna kizazi kinaendelea. Wale wachache tuko nao tunawapeleka kule wakaolewe na wazungu. (When they get there, they find life is hard. A young man will get a man who will invite him to live with him, a young lady will get a fellow woman, who will ask her to marry her. We know that there is an issue our county, there is generation that will not continue. The few we have; we take them to be married there)

Na kwa hivyo, tunapaswa tuwachilie, kama wazazi (We need to let go as parents) because sisi ni wazazi, hata kama sisi ni (we are parents even if we are) Hon. Members, sisi ni wazazi. Kwa hivyo, hiyo jambo ifuatiliwe. Tusione tu (we follow up on this. We just don't see it as an) opportunity, we support. Tunaunga mkono ile mswada lakini pia kama wazazi, tujiulize, mtoto wako akienda, anaenda wapi. Watoto wetu wasiende tena ikawa ya kwamba tumechukua kizazi chetu cha Murang'a tumetupa kule. Na kwa hivyo, mimi naunga mkono, lakini, kuwe na kufuatilia. Pia, nataka nirudi ile mswada ya Wanjengi ya kwamba wale Finland---(We support this motion but as parents, let us ask, when our children go, where are they going? Let it not be that we have thrown away a generation of Murang'a. I support, but we follow up. Let me go back to the Wanjengi motion)

The Temporary Speaker (Hon. Kamwaga Mwangi): Hon. Member stick to the Motion on the Table.

Hon. Priscilla Mwangi: Mr. Speaker, *nilikua nafikiria ile bado ni mambo ya masomo lakini ni sawa wacha nifikishe hapo nina amini ya kwamba mumechukua hio jambo kwa uzito. Ahsante.* (I thought that its still an issue to do with education but let me end there. I believe you have taken this issue seriously.

The Temporary Speaker (Hon. Kamwaga Mwangi): Hon. Member for Murarandia.

Hon. Peter Munga: Thank you, Mr. Speaker, I rise to support the Motion because it is a way of empowering our youth and I am one of them. Also, it is a way of creating job opportunities. Like one of my colleagues has said, because we are making our fellow youth or rather children, as Hon. Priscilla has said, we are taking them there maybe to get employment and education. Also, we should think of how to create employment within our Murang'a County not solely depending on foreign countries. We do not know if in the near future there will be barriers to travel. So, for a

future, we should think of how to create and improve our institution here instead of depending on foreign ones. Also, as a Member of Education Committee, my Chairperson has accepted that the Report was laid or given to him today and I assure Hon. Members speaking on behalf of maybe Education Committee, majority of speakers have said that the document should be subjected to Education Committee and let me assure Members that we are going to thoroughly and deeply look into it. Thank you.

The Temporary Speaker (Hon. Kamwaga Mwangi): I now call the Mover to respond.

Hon. Kibe Wasary: Thank you Hon. Speaker, as I thank Hon. Members for their support on this Motion, one of the Member was asking me outside there when they come here in the Assembly and they want to make their speech in Kiswahili, how are they going to address Hon. Speaker? They know Honourable is *mheshimiwa* but they could not agree on the Speaker word because Speaker *nikipaza sauti*. So, we need some guidance on how to address Hon. Speaker *kwa* (in)Kiswahili.

Mr. Speaker, on the same, let me take this opportunity to thank Hon. Members for their support on this Motion. I want to assure you that the issues that have been raised will be addressed. I am glad to note that the document is already with the Education Committee, it has been confirmed by the Chairperson for Education Hon. Naomi. So, those issues will be addressed. I have also noted that Hon. Chefman and Hon. Priscilla, our Reverend, did not attend the meeting that we had at the Murang'a University of Technology where so many issues were addressed such as the one that Hon. Priscilla was raising. Parents were urged greatly to take those children that they are sure of their interest is education and they are well disciplined.

As a parent, maybe because we know our children, there is a child that maybe you would know maybe, this one if I take there, if I take him or her to Canada, this one will not go there to learn but maybe some other things. So, it was greatly emphasized there in the meeting and we know parents took it very well and positively. Thank you, Hon. Members for your support on this Motion. Thank you.
