# NOTING THE CONTENTS OF REPORT OF FINANCE AND ECONOMIC PLANNING COMMITTEE ON A TRAINING ON INTEGRATED DEVELOPMENT PLANNING

Hon. John Ngugi: Thank you Madam Speaker, I beg to move the following Motion;-

That, this Assembly notes the content of the Report of the sectoral Committee on Finance and Economic Planning of a training on the Integrated Development Planning, laid on the Table of the Assembly on Tuesday, April 25 2023. Madam Speaker, I would like to go to the preamble of this Report and the Report contains the induction of Members of the Committee on Integrated Development Planning guidelines applicable in the development of a County Integrated Development Plan (CIDP) as issued by the National Treasury. This workshop was held on February 16 to February 18, 2023 in Nairobi together with the induction of the newly elected and appointed officials at the County level. The formulation and approval of the CIDP should be the first major task of a new County administration and it should guide all the public spending for the five- year term.

Madam Speaker, I do not wish to read verbatim the content of this whole Report but the gist of it is that the CIDP is the bed rock of all the economic planning tools and all the other budget documents that the County uses to make the County a going concern. The CIDP actually is married to the sectoral Committee plans; the ten- year plans, it is also married to the Medium- Term Paper that is generated by the National Government in the guise to integrate the Counties and the National Government in the 2030 vision.

Madam Speaker, the CIDP entails the policy and legal framework for development planning and this is where the National Government assigns roles of economic policy and planning or the County Government planning and development as stipulated in Article 10 (2) of the Constitution on national values and principles of governance.

Further, prescribes the need for good governance, integrity, transparency and accountability of sustainable development. In this are all the projects, all the programs that the County wishes to conduct in the next five years should be clearly enumerated in the CIDP so that the resources can also be matched with the planning. So, you can see there is a relationship between the CIDP, the Annual Development Plan (ADP), the County Fiscal (CFSP) and the budget itself. So if we do a shoddy job coming up with the CIDP our budget and our planning will not be in congruence.

So, this training was supposed to educate or to sensitize Members of the Finance and Economic Planning Committee on the need to actually bear key interest in how the CIDP is formulated and more so at this juncture where we are in the budget making process.

So, Madam Speaker I would urge the Members of this House to adopt the Report and I call upon my colleague in the Finance Committee team and the Member for Ichagaki Hon. Hillary to second this Report. Hon. Hillary Muigai: Thank you Mr. Speaker, I rise to second the Motion. Thank you.

**Hon. Charles Machigo:** Thank you Madam Speaker for giving me an opportunity to contribute to this Motion. Mine is just to support this Motion and say that they have come up with a very good Report and they have shown that they are well inducted in relation to the guidelines of the application in development of the County Integrated Development Plan (CIDP). Mine is just to urge the Committee of Implementation to ensure that the recommendations here are well followed by the Executive during implementation of the same.

Madam Speaker, if you go through and see the kind of recommendations the Committee gave, they really understood how to formulate a CIDP and all the areas required to be taken care and to be keenly observed during the process of coming up with the Annual Development Plans (ADP). So, on the area of revenue information, and mobilization, you see the CIDP is very clear about the way to organize about revenue and the area of development priorities and strategy. The CIDP provides the details for the spatial development frameworks, laying out the key development priorities. The other area is on expenditure information and none financial indicators. All these, if the County Executive Committee Member (CECM) adhere to the same, we shall have a very healthy County with no problems. Thank you.
