# STATEMENTS

### YOUTH POLYTECHNIC IN ITHANGA WARD

**Hon. Esther Nyakio:** Thank you Mr. Speaker sir, pursuant to the provisions of standing order 45 (2) (c) and part 2 of the fourth schedule of the Constitution of Kenya 2010, that states that ECDE and polytechnics are functions of the County Government, I hereby request for a statement from the Chairperson of Education and Child Welfare, Research, Information Technology and E-Government on the following;-

- 1. Is the chairperson aware that Ithanga ward have no single polytechnic in the entire eight sub-locations of the ward although it's among the priorities in the County Integrated Development Plan?
- 2. Why has the County Government taken so long before the project commences?
- 3. How much money has been allocated for the project?
- When will the project commence?
  Hon. John Mburu: I would request the house to give me seven working days.

# MURANG'A COUNTY SYMBOLS BILL (COUNTY ASSEMBLY BILL NO. 13 OF 2014) (The Speaker left the chair) (Hon. Gachui Mungai Chairing) (Committee of the Whole House)

### CLAUSE TWO

**Hon. Jesse Mburu:** Mr. Chairman, I propose that the Bill be amended by deleting clause two.

(Question that Clause Two be deleted put and Agreed To) (Members said they do not have the Bill)

**The Chair:** Hon. members I am informed that the Bill was sent to you and the amended copy is the one that you do not have. Hon. members we may continue, it is the same Bill that we are amending and I want ....

### (Members insisted that they did not have the Bill)

It is the bill that was put in your files before the second reading. Hon. members I understand this Bill was supplied through your emails and hard copies before second reading. That is the position and let us continue and I want to start from where we started.

### CLAUSE FOUR

Hon. Jesse Mburu: Mr. Chairman I move that the Bill be amended by deleting clause

four.

(Question that clause four be deleted put and Agreed To)

### CLAUSE FIVE

Hon. Jesse Mburu: Mr. Chairman I move that the Bill be amended by deleting clause

five.

(Question that clause five be deleted put and Agreed to)

### CLAUSE SIX

Hon. Jesse Mburu: Mr. Chairman I move that the Bill be amended by deleting clause

six.

(Question that clause six be deleted put and Agreed to)

### **CLAUSE SEVEN**

**Hon. Jesse Mburu:** Mr. Chairman I propose that the Bill be amended by deleting sub-clause one.

Sub-clause two of the Bill be amended by inserting the word 'member' immediately after the word 'executive'.

Sub-clause three to be deleted and replaced by a paragraph reading as follows "Any person who shows disrespect in speech, manner or writing, to or with reference to any symbol of the county, specified likeness or specified name, or any representation thereof, shall be guilty of an offence and shall be liable to a fine not exceeding two hundred thousand shillings or to imprisonment for a term not exceeding six months or to both."

(d) by deleting the sub-clause 10 of the Bill

(Question proposed that the Bill be amended as proposed) (Question put and Agreed to)

*CLAUSE EIGHT* **Hon. Jesse Mburu:** Mr. Chairman, I propose that Clause Eight be part of the Bill

(Question that Clause Eight be part of the Bill put and Agreed to]

### CLAUSE NINE

**Hon. Jesse Mburu:** Mr. Chairman I propose that clause nine be amended by deleting the words 'or to both such fines and such imprisonment' immediately after the word 'months.'

(Question that clause nine be amended as proposed put and Agreed to)

# CLAUSE TEN

**Hon. Jesse Mburu:** Mr. Chairman I propose that clause ten of the Bill be deleted and replaced with the following new clause' 'The County Executive Member may by the notice in the Gazette and with approval of the County Assembly, amend the Schedule to this Act.'

(Question proposed that clause ten be amended as proposed) (Question put and Agreed to)

### NEW CLAUSE 11

**The Chair:** Members, we are now in a new Clause which is guided by standing order number 129 (11). We are inserting a new Clause.

**Hon. Jesse Mburu:** I propose that a new Clause 11 be inserted to the Bill as follows:-'The County Executive Member may make regulations with approval of the County Assembly;

- 1. Prescribing the conditions upon which, the persons by whom and the manner in which the County flag may be flown and displayed as the case may be.
- 2. Prohibiting, controlling, or restricting the use of any specified emblem, specified likeness or specified name.
- 3. Regulating the manner in which any application may be made to the County Executive Member for permission under the Act prescribing the form of any license by which such permission may be given and fixing any fee for such application and license.

**The Chair:** Hon. Members, we are being guided by the standing order number 129 (11).

(Question, that the New Clause 11 be read a second time proposed) (Question, that, the New Clause 11 be read a second time put and agreed to) (Question, that Clause 11 be added to the Bill proposed)

**Hon. Jesse Mburu:** I propose that the Schedule 1 be amended by deleting the Schedule and replacing it with the following new Schedule.

The Chair: Order! Order! Order, Hon. Member

Hon. Jesse Mburu: Sorry, we are all learning.

The Chair: It is okay.

**Hon. Jesse Mburu:** I beg that a New Clause 11 be added to the Bill as follows: 'The County Executive Member may make regulations with approval of the County Assembly;

- 1. Prescribing the conditions upon which the persons by whom and the manner in which the County flag may be flown and displayed as the case may be.
- 2. Prohibiting, controlling, or stating the use of any specified emblem, specified likeness or specified name
- 3. Regulating the manner in which any application may be made to the County Executive Member for permission under the Act prescribing the form of any license by which such permission may be given and fixing any fee for such application and license.

### SCHEDULE

**Hon. Jesse Mburu:** I propose that the Schedule be amended by deleting the Schedule and replacing it with the following new Schedule attached.

**The Chair:** Members, as you understand, the Schedule has been attached but members do not have that can access it in the file for the Order Papers. The attached Schedule is there.

(Question proposed that the Schedule be amended as proposed)

Is there any debate on that? Yes Hon. Bernard?

**Hon. Bernard Kariuki:** Thank you Hon. Chair, I wish to, very strongly, support that amendment because it has captured the aspirations of the people of Murang'a as guided by the Act itself. Hon. Chair, the proposed legislation was initially before the Education Committee and the amendment is part of what this committee has done.

I think they have done a marvellous job, especially on the symbol. Most of the people were very concerned with the prominence of the cow in front whereas in Murang'a County, with your permission Hon. Chair, we talk of *kamuingi koyaga ndiri*. That aspirations of the people has been strongly captured in the Schedule and I congratulate the committee for that. Thank you, Hon. Chair.

The Chair: Hon. Muhoro.

**Hon. David Muhoro:** Thank you Chairman, actually, I may also concur with the proposed amendment. We still have a concern with the head of the cow. If we go by what we have gone through and the far that Murang'a County has gone, I think that this County will live to remember the cow project which is not working very well for the County. However, I may congratulate the committee because they have really tried. Given time or in future, we may be forced to amend on that part with the head of a cow. Thank you, Mr. Chairman.

The Chair: Yes Hon. Kirigwi.

**Hon. Charles Kirigwi:** Thank you Mr. Chairman, I think what is lacking on the Schedule is the meaning of the new symbol. If you look on page 10 of the Bill, they had gone ahead and given the meaning. For instance, the blue means the water, green means cash crops, food crops, and animals. However I need your guidance on the new Schedule. I cannot trace the meaning of the new symbols because I am seeing some hands at the middle. I was trying to look at where the meanings are but I could not.

# *(Hon. Anderson Muchemi rose on a point of information)* **The Chair:** Yes Hon. Anderson.

**Hon. Anderson Muchemi:** Mr. Speaker, I just want to inform Hon. Kirigwi that today we are in the Committee of the Whole House and we are doing the amendments. What is not being amended will still remain in the other original Bill. Today, we are only dealing with the amendments. That is why you cannot see the definitions there.

**The Chair:** I think the Hon. Member for Kinyona is very right. It is good for us to give him time and listen to his views. Hon. Member for Kinyona.

**Hon. Charles Kirigwi:** Thank you Chairman for that information, but even with that information, if we assume whatever Hon. Anderson has said from the meaning that we have here in page 11 is true, where can we trace the hands? It is not there. So, I think the

Chairman may need to clarify where the definitions are because if we amend as he has proposed, we need to have a corresponding meaning on this page. That is what is lacking.

The Chair: I think Hon. Member you are referring to----

Hon. Charles Kirigwi: The picture and page 10.

The Chair: The picture and page 10?

### Hon. Charles Kirigwi: Yes.

**The Chair:** The issue here is very simple because I am being informed that it was the person who was binding this who actually forgot to put in this, but according to what I have here, I think it is according to what you have. Page 10 has described the blue, food crops, cash crops, animal, green, white and black. In fact, it has given the meaning. What was the issue?

**Hon. Charles Kirigwi:** If you look at the meaning, let me just take two minutes to go through. We can see the blue in the new logo, but go to the food crops, Mr. Chairman, are we all there? We have a food crop called avocado. My teacher showed me how an avocado looks like. I cannot trace it on the logo.

### (Hon. Bernard Kariuki rose on a point of information)

**Hon. Bernard Kariuki:** With due respect Hon. Chair, the motion before the House is to amend the Schedule by deleting the Schedule and replacing it with a new Schedule which is before us. Therefore, if we are deleting the whole Schedule, we do not need the rest of the narrative that is in the old Bill because before us is a new Schedule. Thank you, Chair.

**The Chair:** I think the Hon. Member has been guided. Hon. Member, if you go to your file, you said what is lacking in the new Schedule before you were interrupted?

**Hon. Charles Kirigwi:** Mr. Chairman, from that point of information from the Hon. Member for Gaichanjiru, if we are to delete the whole Schedule and insert this, what you lack in this new Schedule is the meaning of the colours and the images.

**The Chair:** Hon. Member, I know this is a very hot issue because it is just a matter of just passing it now and it will be a point of reference in future, but again, I agree with you that it was supposed to be brought together with the flag. However, we are going to treat that like an omission.

I am sure the Office of the Clerk was meaning well even if the members of staff who were doing this actually omitted that. But if you remember, it was there in the report and it was well covered. Am I right, Chair? It was well covered. That is a very good observation.

(Hon. Hon. Duncan Njuguna rose)

Yes, Hon. Duncan

**Hon. Duncan Njuguna:** Mr. Chair, we need your guidance. Is it in order for us to adopt omissions? If something is not there because maybe whoever was typing or printing the Schedule forgot, we cannot just assume that he or she forgot and we adopt the same.

**The Chair:** Hon. Members, I think it is not an external force. It was our staff who did this. It was covered in the report that was tabled and debated in this Assembly. I think, Hon. Members, you have the report.

### (Hon. David Muhoro rose)

### What is it Hon. Muhoro?
