#### MURANG'A COUNTY APPROPRIATION BILL, NO. 5 OF 2015 - FIRST READING

*(The Bill was read for the First Time)*

#### MURANG'A COUNTY APPROPRIATION BILL, NO. 5 OF 2015- SECOND READING

**Hon. Peter Mweri:** Thank you Mr. Speaker, I now beg to move;-

That, the Murang'a County Appropriation Bill number 5 of 2015, be read a second time.

Briefly, this Bill was drafted after the budget was passed on 24<sup>th</sup> June 2015, which was last week. It is a requirement that the Bill is brought to the House. This Bill of 2015 will be an Act of the County Assembly of Murang'a and will authorise the issuance of money into the Murang'a County Revenue Account. Its application is towards the service of the Financial Year (FY) ending 30<sup>th</sup> June 2016 and to appropriate sum voted on account by Murang'a County Assembly for certain public services.

Mr. Speaker sir, the money that is supposed to be authorised and to be used by Murang'a County totals to Kshs. 6,658,909,000, and out of that, the National Government will give Kshs. 5,785,909,000 and we anticipate to get local revenue of 850 and Danida support of Kshs. 23,000,000. I call Hon. Gitau to second. Thank you Mr. Speaker sir.

**Hon. Joseph Kimani:** Thank you Mr. Speaker sir, I am a Member of the committee of Budget and Appropriations and I hereby stand to second that the Murang'a County Appropriation Bill No 5 of 2015, be now read a second time.

I must say that this is one of the best Bills that we have because, as you can see, out of the 6.6 billion, we are going to put about 48% of the total to our capital development which means that the Murang'a government really is caring for its people at the grassroots and we hope that this 48% development money will benefit our people, I second.
