#### ESTABLISHMENT OF ALCOHOLIC CONTROL DIRECTORATE

Hon. Rebecca Mwicigi: Mr. Speaker sir, I wish to give notice of the following motion;—Aware, that section 4 (1) of the Murang'a County Alcoholic Drinks Control Act 2014, establishes the County Alcoholic Drinks Directorate, cognizant of the fact that a high number of dependants of alcohol in the county are currently suffering from withdrawal syndrome due to non-consumption of alcohol; this Assembly urges the County Executive Committee Member in charge of Health Services to establish the Alcoholic Control Directorate which shall;

- 1. Establish treatment and rehabilitation facilities and programmes for persons dependent on alcoholic drinks.
- 2. Ensure the treatment and rehabilitation facilities have the necessary human resource for effective operation.
- 3. Ensure that the treatment and rehabilitation services are designed in a manner that is accessible and affordable to persons dependent on alcoholic drinks.

### PAYMENT OF VALUATION DEBT OWED TO MUIYURO, MUIRURI AND COMPANY CARRIED FORWARD FROM MARAGUA TOWN COUNCIL

The verification for all the assets and liabilities the county government inherited from the seven defunct local authorities is in progress. This debt will be considered alongside other debts once this verification exercise is completed. The final report will be tabled in the House for deliberation/

## RECOVERY OF RENT FROM DEPUTY GOVERNOR FOR HIS OFFICIAL RESIDENCE

**Hon. Samuel Wandia:** Thank you, let me take the honour to respond on this question which was raised by Hon. David Muhoro, MCA Kariara ward from the chairperson Finance and Economic Planning on the recovery of rent from the Deputy Governor for his official residence.

Mr. Speaker , the committee of Finance and Planning vide a letter reference number MCA/C/5/8/VOL.2 dated  $9^{th}$  April 2015 sought a response from the CEC member for Finance, IT and Planning where the said CEC was expected to avail a response on or before Wednesday, April  $22^{nd}$  2015.

The CEC responded nevertheless, the committee observed that the said matter was human resource in nature since it contemplated house allowances of a state officer. This is within the province of the Public Service in the executive, and falls under the purview in the committee on Governance, Labour and Social Welfare, Justice and Legal Affairs in the County Assembly

Consequently the response was redirected to the committee of Governance, Labour and Social Welfare, Justice and Legal Affairs which is deliberating on the same and is expected to report to the House at the earliest convenience.

Mr. Speaker, I took pains to approach the chairman of Governance, Labour and Social Welfare, Justice and Legal Affairs and he has told me that if he is given seven days he will avail the answer, thank you.

**The Speaker:** Once again it appears like Hon. David Muhoro is not around to follow up the answer and I will just like to emphasize also that to show seriousness in business, once

somebody asks a question he should sufficiently be interested to be around when the question is being answered, that shows a lot of seriousness.

Of course I do understand in case of Hon. Machiri but there should be no excuse for anybody to ask a question and not be around when it is being answered.

I would also like to alert the Hon. members that when a question is answered even if you are not the person who initially asked the question and you are interested in the answer given you can still follow up to answers given, anybody can follow up to the answer that is given.
