REQUEST ON THE STATUS OF ROADS AND BRIDGES IN MAKUYU WARD

- ii. Is he also aware that Mithini-Kinoo bridge is in a dilapidated condition thus hindering vehicles from accessing Kinoo primary school?
- iii. Is he further aware that Kiyoo Nama-Mugumoini road is in a deplorable condition thus rendering it impassable by vehicles?
- iv. Can he therefore inform the Assembly when the aforesaid road and the two bridges will be repaired?
