STATEMENTS

TRANSFER OF MR. PAUL N. KAMAU (SENIOR ASSISTANT CHIEF PUBLIC HEALTH OFFICER) TO KIGUMO SUB-COUNTY

Hon. Jesse Mburu: On May 26th 2015, Hon. Kirigwi requested my committee to give an answer concerning the transfer of Mr. Paul Kamau from the Murang'a county health office to Kigumo.

On July 22, 2015, I gave a reply to this House but there were a few details missing so the committee decided to compile another report. I must apologize because this statement has taken quite some time but it is due to the process of getting a statement from the health director.

Hon. Kirigwi wanted to know whether I was aware that Mr. Paul Kamau, 57 years old, who has been serving as the county public health officer from 2010 to recently has been transferred by the current director of health to Kigumo sub-county as a sub-county public health officer.

We invited Mr. Kamau and the director herself and they briefed us of what transpired. It is true that Mr. Kamau was transferred to Kigumo sub-county which is a junior office to the office he was holding, but then we discovered that he had some weaknesses, and that is why he was transferred.

The eight sub-county public health officers met and they passed a vote of no confidence against their boss and again Mr. Kamau had been accused of going against the Public Health Officers Act which he was supposed to be working under. He never refrained from drinking and he was drinking alcohol during the day with his juniors. He was smoking in public and he was unable to discharge his duties.

When he was called upon by the director to explain himself, he admitted all this accusations and he promised that he was going to change. When we called him in the committee he admitted that all the accusations were true and he said that he was happy because when he was transferred to a junior office his salary was not touched, his allowances were not affected and he is the one who told the director that instead of being taken to Kangema where he was to go initially, he be taken to Kigumo.

He confirmed to the committee that the allegations were true and he has changed since then. This was also confirmed by the director that when he was taken to Kigumo he was under close supervision and the director has seen change in the office.

He has three years to retirement and he requested that this matter end there because he has improved in his work, he is sending the reports as required by his office. He no longer drinks with his juniors, he no longer drinks beer nor smokes; those were the accusations.

Again he was irresponsible when he was at the headquarters because when there was a cholera outbreak, he was unable to mobilise his officers as required and he said he has improved.

He is the one who told us in the committee that this matter should rest there and the director herself Dr. Kanyi has also implied that there is a lot of improvement in Mr. Kamau's performance.

With this, I would request the members to let the matter rest there because the parties are satisfied and we move on. Thank you Mr. Speaker
