COMMITTEE ELECTIONS

The Speaker: Hon. members, pursuant to standing order 189 (4) and 190 (4), the members elected to sit in the County Public Investments and Accounts committee (PIC/PAC) and the Budget and Appropriation committee elected following a general election shall serve for a period of three years.
