COMMUNICATION FROM THE CHAIR

ADDRESS BY THE CHAIRMAN OF THE COUNCIL OF EMINENT PERSONS OF MURANG'A

Hon. members, sometime ago I received a request from a Council of Eminent Persons of Murang'a and they requested that they would wish their chairman Hon. Charles Rubia to come and address the members of this Assembly.

We accept his apologies and tomorrow the business of the House will be on a supplementary order paper and the business that had been put aside due to this event will resume. I request you to accept his apologies knowing that he is the one who requested to address this Assembly.
