# KAHUTI WATER AND SEWERAGE COMPANY (KAWASCO)

**The Speaker:** Pursuant to the standing order 204 (2) (b), I wish to report on July 20,2016 the County Assembly received a petition from Catherine Wangui I.D no. 24808722 on behalf of residence of Gitui village within Murang'a county.

The petition draws the attention of the Assembly to the matter of investigation of Kahuti Water and Sewerage Company Limited (KAWASCO), a water service provider owned by Murang'a County Government for misleading Kiharu Constituency Development Fund to fund a project that was not viable.

I further wish to state that the petition is signed by 29 petitioners and that the petitioners confirmed that the issues raised are not pending before any court of law, Constitutional or legal.

The petitioner prayers are; that the company management be investigated and prosecuted for misleading the community of Gitui.

The management be summoned by the County Assembly of Murang'a to explain why they fail to give water to the community despite completion of the project.

That the House resolves to remove the management of Kahuti Water and Sewerage Company Limited and the Chief Executive Officer on account of incompetence.

Pursuant to the provision of standing order 206 (1) the petition is hereby committed to the sectoral committee on Water, Energy, Forestry, Natural Resources and Co-operatives.

Further, pursuant the standing order 206 (2) the committee shall in not more than 60 calendar days from today respond to the petitioners by a way of a report addressed to the petitioners and lay on table of the Assembly. Thank you.
