CONSIDERATION OF REPORT OF COMMITTEE OF THE WHOLE HOUSE

Hon. Bernard Kariuki: Hon. Speaker, I beg to report that the Committee of the Whole Assembly has considered the Murang'a County Trade Licensing Bill, No 3 of 2015 and its approval thereof with amendments.

Madam Speaker, the Committee of the Whole has looked at the Bill. The purpose of this Bill is to provide for the implementation of Section 7 of the Constitution. That is in the Fourth Schedule and it is about the functions of the County Government.

While looking at this Bill, the Committee of the Whole House has tried to evaluate it, in terms of establishing an environment that is conducive for business so that the Bill does not strain our entrepreneurs.

The amendments that have been proposed by the Mover of the Bill were generally to align the Bill to general provisions of the Constitution, in terms of fairness, equity, and such issues. Therefore, the Bill was dealt with thoroughly by the Committee of the Whole House.

Thank you Madam Speaker.

Hon. Isaac Kamote: Madam Speaker, I beg to move that the Assembly agrees with the said report by the Committee of the Whole House. I request Hon. Kago to second the Bill.

Hon. Kago Njoroge: Thank you Madam Speaker, I second that the Assembly agrees with the Committee of the Whole House on the said report.

It is important for the Members to remember that we went for the public participation as provided for by the Constitution and some of the amendments are what we gathered from the public. Since the Whole Committee has agreed with us, I second the motion.

Thank you Madam Speaker. **Second Chair:** Thank you.

Hon. Isaac Kamote: Madam Speaker, the Committee of Trade is happy that the House has adopted the amendments and the Executive should now take up the matter. Thank you Madam Speaker.

MURANG'A COUNTY TRADE LICENSING BILL NUMBER 3 OF 2016- THIRD READING

Hon. Charles Kirigwi: Thank you Madam Speaker, I beg to move that the Murang'a County Trade Licencing Bill No.3, 2015 be now read a third time.

Hon. Kago Njoroge: Madam Speaker, I hereby second that the Murang'a County Trade Licencing Bill No. 3, 2015, be now read a third time---

Hon. Duncan Njuguna: On a point of order Madam Speaker---

Second Chair: Yes Hon. Duncan.

Hon. Duncan Njuguna: Is it in order for the Hon. Member of Kangari and the Hon. Member for Kigumo to continue consulting loudly thereby interrupting the business? That is why Hon. Kamote was confused and talked of the Executive instead of concentrating on the third reading.

Second Chair: The Members should consult quietly or softly. They are out of order.

Hon. Kago Njoroge: Madam Speaker, this is one of the Bills that are of help to our business community because you will remember that we have been using the by- laws of the defunct councils and some of them have been harsh to our traders.

You know that we had around seven defunct councils, which were merged to create Murang'a County and each of them had different by-laws which were being enforced. I remember one member who complained that boda boda operators are being charged Kshs. 1,700 whereas those in another ward are being charged Kshs. 1,500.

Madam Speaker, this Bill will bring equity when it comes to charging and enforcing. We therefore feel that it is a privilege to our members of public, especially the traders within Murang'a County. We hope that they are going to embrace this and co-operate.

We also urge the County Executive to enact this as soon as possible because it will also help us cover the loopholes through which our county has been losing money.

When we come to revenue collection, we feel that the members of our business community will never be harassed with laws which they are not aware of because during the time when the by-laws of the county were being made, nobody could go to them and ask them or request them to participate. But Madam Speaker this time round they have participated and they know what is happening. When they open our website they know what is going on.

We have also appreciated the memorandums which they have sent to us as the committee which we have put into considerations in the amendments we have done. Without much ado I hereby second that this bill be read a third time.

(Question proposed)

Hon. James Kagoni: I thank you Madam Speaker, I rise to support the bill that is on the table.

I see here benefits from this Bill, when you read the memorandum of this Bill you realise that one of the reasons why we have not been able to come up with a Finance bill. In fact in this county we have bill relying on the Finance bill that we enacted in year 2013/2014

is because a lot of input for Finance bill is supposed to come from the Bill that we have just passed.

Therefore, going forward Madam Speaker, we will be able to come up with a very comprehensive Finance Bill because much of the information we require to update, delete, amend which part of information is contained in the Finance Bill will now be coming from what has been established by this Bill, which is a licensing unit and that is very crucial.

I remember sometime back we were even taken to court as a county because many residents were raising issues to do with the Finance bill and they were saying that we did not involve the public much and many things kept changing. How much we were charging the lorries last year because of many economic factors we might realise that we need to change it.

With a licensing unit that has been established by this Bill we are able to update or listen to the residents and change some of those things. And therefore we are able to come up with a very comprehensive Finance bill for every budget cycle.

Benefit number two is that from this particular Bill we are now able to get an opportunity for young people to be employed because the licensing unit that has been established by this Bill requires some people to be sitting there, it also requires chief licensing officer to be sitting there. That is crucial because it is an employment opportunity for young people in the county and we have a number of them in the county who have done economics and others finance and they are still looking for jobs. These are opportunities that are coming in that regard.

Number three is that many of our members seated here will tell you that any time young men have been harassed here and there because they are being asked for licenses and perhaps others are claiming they paid this much and now they are asked to pay this other. Sometimes you wonder where you send them to. Now this Bill establishes an office that will be dealing with all those matters.

So things will become very easy like Hon. Member from Mugoiri was saying you are able to come with a document that is in tandem with every other regulations, every other charge, every other fee that you are supposed to pay. And in case of any complaint or any other matter that needs to be listened to there is that office that is supposed to do so.

Therefore, Madam Speaker this Bill is a Bill that is long awaited, it is a Bill that we needed to have in year 2013/2014 to be able to have Finance bill subsequently. However we appreciate that we are not late, we want to appreciate the committee of Trade specifically the chairman for what we have been able to do under his leadership and I fully support this Bill. I thank you Madam Chair.

Hon. Bernard Kariuki: Thank you Madam Speaker, I wish to take this opportunity to support the Bill and congratulate the sponsor of the Bill.

It is very encouraging for this Bill because it seems to implement part of our functions under schedule four and I think we have a duty as an Assembly to make sure before the expiry of this Assembly we enact at least half of the laws required to implement schedule four functions.

This is credible and I support this Bill. My only concern was on section six on the provisions for the chief licensing officer. I think after enactment of this Bill it will be important for the committee or the mover to consider amending that section to provide that the officer be vetted by the Assembly; I feel that position is the same position as a chief officer. That requires vetting by the Assembly so that we get the right person.

Madam Speaker section 31 on enforcement of this Act is very important. When we met in Nyeri, when we had the President, one of the issues that arose is that the licensing regime of the county governments is not favourable to business.

I would request that the implementation of the Act, if it is approved, enforcement must be within the confines of the Constitution and should be able to promote business environment so that we are not seen as debt collectors.

I also want to appreciate section 37, I would request the chairman for Trade to follow up with the CEC, so not unless the CEC makes regulations to implement the Act it could gather dust in the shelves.

Therefore Madam Speaker this is a very important Bill to structuralize licensing regime in the county which is very important. And I think this is the way to go I support.

Hon. Peter Kariuki: Thank you Madam Speaker, I want to congratulate the committee of Trade for what they have done.

Mine is not too much but what I would request they have not talked about people with disabilities in business and there are people who have business and some of the people are not able to pay the licenses. They would have talked a bit on disability issue in terms of business. Thank you Madam Speaker.

Hon. Peter Mweri: Thank you Madam Speaker, I rise to support the Bill but before I support I would like to make an observation that this room is too hot, I think the office will do something.

This Bill has come at the right time, the last two years we have been in the office and this is the third year. We have been having problems with enacting the Finance bill and this will help a lot because it will give a guideline as to how Finance bill will look like.

I am motivated by clause 30 about reporting. The Bill has given a lee way after one calendar year, there will be an evaluation on the Bill so that if there are gaps they can be catered for.

I have also noted that as the hon. members have said, there has been a lot of public participation. Even before the other Bills are implemented, the public is consulted and it is good that they are aware about it. And it will be very easy even on implementing the Bill.

It has given the standard on how the license should be and this is a point plus to the sponsor of the bill. Otherwise Madam Speaker I stand to support.

Second Chair: Hon. Kirigwi

Hon. Charles Kirigwi: Thank you Madam Speaker, mine is to really thank the members who have contributed in the reading the Bill for the third time.

And I am very optimistic this time because we walked this road with executive that the county CEO who is the Governor will for once sign a Bill that is emanating from this Assembly. I understand that it is only the Appropriation Bill that has been signed, we look forward for first implementation once it is signed.

About the issue raised by Hon. Wanyoike, about vetting the chief licensing officer, we looked at that deeply in the committee and we found that we do not want to micro-manage the executive and we do not want this Assembly to go so low to vetting people even on calibre of directors.

We thought that because we have a substantive chief officer for Trade, in fact three chief officers and we thought that we give the County Public Service Board that lee way to do its work so there is no need of vetting chief licensing officer.

So I ask members to support the motion that the Bill be read a third time so that we can have a law called Murang'a County Licensing Act 2015. Thank you.
