## REQUEST ON KENOL LIVESTOCK MARKET YARD

**Hon. David Kabaka:** Hon. Speaker, I represent the good people of Kambiti ward and I stand to request for a statement on behalf of my neighbour, hon. Eliud Gitau Kabuthi, who is the Member of County Assembly (MCA) for Kimorori ward. As per standing order 45 (2) (c), I request for a statement from the chairperson for Trade, Industries, Tourism and Wildlife committee as follows:-

- 1. Is the chairperson aware of the existence of Kenol livestock market yard?
- 2. If the answer is in the affirmative, is he aware that the livestock market yard is now under a private developer who has currently demolished the structure which was previously renovated using the tax payers' money?
- 3. Can the chairperson provide details on the type of the business currently being undertaken in the yard by the said private developer?
- 4. What measures is the chairperson and the department undertaking to safeguard the interest of the Kenol community who are supposed to conduct business in the yard?
- 5. When will the yard be officially opened for livestock business?
