# PRAYERS COMMUNICATION FROM THE CHAIR

The Speaker (Hon. Nduati Kariuki): Hon. Members, as you are aware, this special sitting was convened in accordance with the law for the purpose of transacting very crucial business of the Assembly.

Pursuant to standing order 20, the largest party or coalition of parties in the Assembly is required to elect a member of the Assembly belonging to the party or coalition of parties to be the Leader of the Majority Party; (b) a member of the Assembly belonging to the party or coalition of parties to be the Deputy Leader of the Majority Party.

Pursuant to standing order no. 20 (6), I wish to confirm that the party did submit their decision of hon. members elected to the positions vide a letter dated September 08, 2017. The elected party leadership is as follows:-

1. Leader of Majority Party - Hon. Erick Kamande Kimani

(Applause)

2. Deputy Leader of Majority - Hon. Joyce Wambui Njoki

(Applause)

3. Chief Whip - Hon. Simon Mwaura Wamwea

(Applause)

4. Deputy Chief Whip - Hon. Ruth Wambui Karanja

(Applause)

The Speaker (Hon. Nduati Kariuki): I wish to notify hon. members that the House as currently constituted does not have a minority party. Pursuant to the County Assembly standing orders an 'Assembly party' as defined means a party or a coalition of parties consisting of not less than five percent of the membership of the Assembly. According to my calculations, those are about three members.

I now confirm that the Assembly of Murang'a does not have a minority Assembly Party. Five per cent of the membership translates to three members. Apart from Jubilee Party, there are only two other parties namely the Democratic Party and the Maendeleo Chap Chap which have two and one members respectively.

Consequently and since there is no minority Assembly party, this House does not have a Minority Leader, a Deputy Minority Leader, a Minority Whip and a Deputy Minority Whip.

For the purpose of selection into the committees and all other businesses, I will treat all members as members of Jubilee or associated with Jubilee; there will be no discrimination. In any case, the Democratic Party and Maendeleo Chap Chap are associated to Jubilee and I know in the heart of even the independents are Jubilee at heart and they went independent for the convenience of the elections, they will be treated as members of Jubilee and they will not be discriminated.

However, a few have asked whether they can form a caucus of independent members and I have told them to put that to me in writing, and I will decide whether it is legal and convenient for them to be treated as an opposition party. Otherwise, as at now, we shall treat them as Jubilee members and this has been agreed by the Jubilee leadership that they are ready to take them on as Jubilee leaders. I now confirm to the Assembly that at the moment we do not have a minority Assembly.

Membership to select committees, Hon. Members, standing order 165, 166 and 198, requires that the following committees be constituted as soon as a new Assembly is convened.

- 1. The House Business and Rules committee standing order no. 165
- 2. The Committee on Selection standing order no. 166
- 3. The Committee on Appointments standing order no. 198

These are the committees that must be immediately elected since this will give us an opening to start other businesses of the house including appointment to the other committees; I wish to confirm that the Leader of Majority has submitted the names of the Hon. Members who have been placed to serve in the three committees. The Leader of Majority shall move a motion of approval of the membership of the aforementioned three committees.

Hon. Members please note that besides the three committees whose memberships shall be approved today due to their set timelines in the standing orders, the County Assembly consists of other sectoral and select committees as follows; we shall have committees on;

- 1. Agriculture, Livestock and Fisheries
- 2. Education and Child Welfare, Research, information technology and E- Government.
- 3. Water, Energy, Forestry, Environment and Natural Resources
- 4. Governance, labor and Social Welfare, Justice and Legal Affairs.
- 5. Land, Housing, Physical Planning and Settlement.
- 6. Health Services.
- 7. Youth, Culture, Gender and Social Services.
- 8. Public Works, Roads and Transport.
- 9. Trade, Industrialization, Cooperative Management, Tourism and Wildlife.
- 10. Finance and Economic Planning

The Speaker (Hon. Nduati Kariuki): Honorable members; what I am trying to explain to you is that there are very many committees to fill, if you are not in any of the committees, I can assure you that all of you are qualified to serve in the committee, but a few had to be selected to serve in the Assembly and this could not have been everybody. All the other members who are not in this committee have a wide choice to choose from and a member will be expected to serve in at least 3 committees. It will help the members, secretariat and the selection committee if the members indicate where they are best suited to serve and where they can use their talent best. We have many Talents in this house, health, Technology, IT. There are a lot of talents in this house. And these talents will be very useful in this committee.

If you apply to be a member of a committee, it will be only for guidance since positions have to be distributed evenly and one may not necessarily be in the committee he wishes to be. If we do this, we might find that all people are in one committee and there are committees without people. It is good for members to state where they can serve best but it will not be automatic for you to be in that committee. I hope this is clear.

Hon. Members, pursuant to Article 179 (2) (b) of the Constitution of Kenya, 2010, section 8 (1) of the County Governments Act, 2012 and Section 7 (1) of the Public Appointments (County Assemblies Approval) Act 2017, the Governor Murang'a County, through a letter Ref: MCG/GOV/ST/2/1(1) dated September 15, 2017, submitted a list of six (6) nominees for appointment to the positions of County Executive Committee Members (CEC'S) as follows;

This is important because the law requires these members to be appointed within 21 days since the date when the members of the County Assembly were sworn in. That day ends on 25<sup>th</sup> Monday next week. After receiving the names from the Governor we had to call for this urgent meeting. The members to be vetted and later approved are as follows;

Hon. Members, pursuant to section 7 (4) and (5) of the Public Appointments (County Assemblies Approval) Act 2017, the Clerk through an advertisement in the Daily Newspapers on Sunday 17, 2017 notified members of the public on the time and place for the approval hearing. In this regard and pursuant to section 7 (3) of the Public Appointments (County Assemblies Approval) Act 2017, the Committee on Appointments will undertake vetting/approval hearing of all the nominees on Monday September 25, 2017 in the County Assembly Chambers, Assembly buildings. Subsequently, members are put on notice that there will be a special sitting on Monday September 25, 2017 at 2:30 p.m. for consideration and adoption of the report of the committee on appointments on the above mentioned.

Lastly Honourable Members, standing order no.16 (1) requires that within 30 days after the swearing in of the Speaker, the Assembly is required to elect a Deputy Speaker from amongst its members who shall preside over any sitting of the Assembly in the absence of the Speaker. Pursuant to Article 178 (2) (b) of the Constitution of Kenya 2010, as read together with section 25 of the Elections Act 2011 and County Assembly standing order no. 16, the Clerk declared a

vacancy in the office of the Deputy Speaker of the Murang'a County Assembly on September 15, 2017.

Consequently, interested Members of the County Assembly were required to collect nomination forms and return them by Tuesday September 19, 2017 at 2:00 p.m. Hon. Members, I wish to confirm that the following candidates were validly nominated for the position of Deputy Speaker of the County Assembly, as at the close of the nomination period:-
