AN Act to authorize the issue of certain sums of money out of Murang'a County Revenue Fund and their application towards the service of the year ending on the 30th June, 2013, and to appropriate those sums for certain public services and purposes

Enacted by Murang'a County Assembly, as follows-

1. This Act may be cited as the Supplementary Budget Appropriation Act, 2013.

Short title.

2. The County Treasury may issue the sum of money as indicated in the third column of the scheduled in place of what was previously approved through Murang'a County Appropriation Act No. 1 of 2013.

Issue of KSh. 5621869000 out of Murang'a County Government Revenue account for the service of the year ending June, 2013and appropriation of money granted.

3. The sum granted by section 2 shall be appropriated for the several services and purposes in the respective departments and spent as provided for by the various regulations, Public Finance Management Act, County Governments Act and the Constitution. Appropriation of the money granted.
