**ADOPTION OF REPORT OF FINANCE AND ECONOMIC PLANNING  
COMMITTEE ON THE COUNTY INTEGRATED  
DEVELOPMENT PLAN (CIDP) FOR 2018 – 2022**

**Hon. Kiiru Mwangi:** Thank you Mr. Speaker I beg to move the following Motion;-

That, this House adopts the report of the sectoral committee on Finance and Economic Planning on the Murang'a County Integrated Development Plan (CIDP) for 2018-2022.

Pursuant to the County Governments Act 102 up to 107, the planning frame work of a County Government is a key document that informs all other policies and budgetary processes of expenditure of every County.

Following what we had this morning it is good to clear the air, we have had our meeting, Finance and Economic planning committee and we have agreed; I want this to be in Hansard, that from the clerk assistant and the Hansard there was no meeting or an invitation for the adoption of the report, there were no minutes to adopt the said report and since there was no meeting, there was no Hansard report for the same. There was no meeting that adopted the report pursuant to standing order 93.

However, in the spirit of the handshake in this country, we have agreed as a committee, for purposes of this County moving on, let us have the adoption of the report with amendments since we have the approved budget estimates and life goes on.

The report is in our files and the appended amendments have been attached. All the projects that were included in the County Fiscal Strategy Paper (CFSP) 2018/2019 should be included in the CIDP and the ADP. I do not want to go through the entire report, there are recommendations there and I want to request this House, in order to

correct the anomalies and have the planning framework in place as I had quoted in the County Governments Act, I urge this honourable House to adopt this report on the CIDP and there is provisions for amendments, if anybody feels there is something that was left out according to standing order 228. I now call the vice -chairperson Hon. Wambui Njoki to second the Motion.

**Hon. Wambui Njoki:** Thank you Mr. Speaker, I am here to second the report on the adoption of the CIDP. The CIDP has 10 sectors that cut across the sectors of the committees, that start all the way from Finance to Governance. This highlighted the findings of the sectoral committees. It also accounted for the construction of the few things we need done in the Assembly.

We have a circular from Salaries and Remuneration Commission (SRC) that says that the Speaker and the Governor will not have the house allowance from July this year. To that effect we have included Kshs100million for the construction of the Speaker's residence. We have also included the County Assembly office block which is costing Kshs30million and the County perimeter wall that is costing Kshs20million. I will urge this House to support the Motion, I second.
