**THAT,** the report of the Health Services Committee on Fact Finding Visits to Gitura Dispensary and Kandara Sub-County Hospital In Kandara Sub-County be laid on the table of the Assembly.

### 6\* NOTICE OF MOTION - FORMULATION OF A POLICY ON STREET LIGHTING IN URBAN CENTERS

(Hon. Sospeter Nyoko – MCA, Mugoiri Ward)

**AWARE**, that County transport which includes street lighting is a devolved function as stipulated in part 2 of the Fourth Schedule of the Constitution of Kenya, 2010, further aware that most street and flood lights in urban centers of Murang'a County have malfunctioned leading to high cases of insecurity experienced at night through mugging of the residents and break- ins of the various premises, recognizing the fact that this has been caused by lack of maintenance of street and flood lighting system in these urban centers and lack of proper fitting of security lighting systems on various premises; **this** House urges the County Executive Member for transport and infrastructure to develop a policy providing that;

(a) All business premises are installed with operational streetlights;

(b) Street lighting be a condition precedent to issuance of trade licenses;

(c) Street lighting unit be established to install and maintain street and flood lights in all parts of the County.

### 7\* NOTICE OF MOTION - FORMULATION OF A POLICY ON REGULAR INSPECTION OF ACCESS ROADS IN SHOPPING CENTERS

(Hon. Sospeter Nyoko – MCA, Mugoiri Ward)

**AWARE**, that County transport which includes County roads is a devolved function as stipulated in part 2 of the Fourth Schedule of the Constitution of Kenya, 2010, further aware that most access roads in shopping centres of Murang'a County are in a dilapidated condition manifesting itself through pot holes and poor drainage systems, recognizing the fact that this has been caused by lack of periodic maintenance of these access roads; **this House** urges the County Executive Member for transport and infrastructure to develop a policy providing that;

- (a) Regular inspection of access roads serving all the County shopping centers be conducted to determine their condition;
- (b) Periodic maintenance and rehabilitation of the said access roads be informed by the regular inspection be conducted to enhance accessibility.
