6* NOTICE OF MOTION - SOLAR POWERED BOREHOLES IN ITHANGA WARD

AWARE that Sustainable Development goal (SDG) 6 envisions clean water and sanitation, further aware that Article 43 (1) (d) of the Constitution of Kenya, 2010 guarantees every person the right to clean and safe water in adequate quantities, cognizant of the fact Vision 2030 contemplates resilience of water supply and sanitation in the face of climate change, alive to the fact that water distribution is a function of the County Government pursuant to the Fourth Schedule of the Constitution of Kenya, 2010 and that the County has drilled boreholes in Ithanga Ward to enhance supply of water which are electric powered, alive to the high power costs disabling constant supply of water to the residents of Ithanga due to non-payment of power bills; this Houses urges the County Executive Committee Member for Water to:

- i. Ensure that all boreholes in Ithanga Ward are solar powered; by installing;
- ii. Ensure proper maintenance of the installed solar panels to guarantee residents constant supply of clean drinking water;
- iii. Allocates adequate funds in the FY 2019/2020 for the installation and maintenance of solar panels;
- iv. Put in place control measures to ensure the funds allocated are expended for the purpose for which they are intended and regularly furnish the Assembly with reports on the extent of water connectivity.

7* NOTICE OF MOTION - QUARRY MINING IN ITHANGA WARD

AWARE, that Article 66 of the Constitution, 2010 underlines the requirement for local communities to benefit from the local resources, further aware that quarry mines in Ithanga attract people from within the County and the neighboring Counties such as Machakos, who use the feeder roads to transport the quarry extracts, rendering them deplorable, mindful of the fact that the spirit of the Constitution underscores the rights of the sons of soil on the proceeds realizable from the local resources; this House resolves that:

i. The County Executive Member in charge of Finance, IT and Economic Planning

- a) Erects barriers at strategic points of the roads leading quarry mines, to allow for collection of fees and levies from the lorries, and thereafter use the monies collected in entirety to rehabilitate all feeder roads in Ithanga Ward;
- b) Submits quarterly reports to the County Assembly, on collections from the quarry barriers and expenditure reports of the said monies;

ii. The County Executive Member in charge of Energy, Transport and Infrastructure

- a) Prepares a work plan on how to improve the feeder roads in Ithanga Ward where the work plan should be based on projected revenues from quarry barriers, and subsequently submit the work plan to the County Assembly within two months following the adoption of this Motion;
- b) Submits quarterly reports to the County Assembly on the roads graveled and compacted in Ithanga Ward from the monies collected from the said quarry barriers.
