REQUEST ON SURRENDER OF PUBLIC MARKETS IN KAGUNDU-INI WARD

**Hon. Mburu Muthoni:** Thank you Mr. Speaker, I hereby request for a Statement pursuant to Standing Order 46 (2) (c) from Chairperson Trade, Industrialization, Co-operative Management, Tourism and Wildlife Committee as follows;

1. Is the Chairperson aware of existence of Kagundu-ini open goat market and Kariti market in Kagundu-ini Ward?
2. Is he also aware that half of Kagundu-ini goat market and the whole of Kariti market were grabbed?
3. Is he further aware that two private developers who grabbed Kariti market are willing to surrender it back to the public?
4. If the answer is to the affirmative, when will the two markets be surrendered back to the public?

**Hon. Gerald Wambugu:** Thank you Mr. Speaker, I have stood on a point of order to argue on the Statement raised by the honorable member from Kagundu-ini ward. This is because according to me, this issue should be addressed by my Committee; Land, Housing, Physical Planning and Settlement because the matter on contention here is land. Thank you.

**Hon. Stephen Chege:** Thank you Mr. Speaker, on behalf of the Chairperson, I request that the two Committees that is Trade, Industrialization, Co-operative Management, Tourism and Wildlife Committee and Land, Housing, Physical Planning and Settlement can address that issue harmoniously because it is touching the market and the land. We can do that in two weeks.
