11* MOTION - PREVENTION OF INDECENT SEXUAL ORIENTATIONS IN THE COUNTY

(Hon. Elizabeth Wambui – MCA, Kimorori Wempa Ward)

AWARE that Article 27 of the United Nations Universal Declaration of Human Rights grants us the right to freely participate in the cultural life of the community, to enjoy the arts and to share in scientific advancement and its benefits, further aware that the cultural life of a community should be respected as the basis for social harmony, recognizing that the present civilization is a product of cultural norms and morals that have enabled humanity to make and sustain progress across many centuries, concerned that there have been efforts by wayward personalities and foreign organizations to undermine our cultural and moral codes by promoting homosexuality as a way of life, infuriated at the open disrespect that these organizations and individuals are demonstrating on our right to enjoy our

culture, informed by Section 162 of the Kenyan Penal Code, CAP 63 that prohibits sex against the order of nature, and Section 165 of the Penal Code that declares homosexuality a gross indecency that attracts imprisonment, **this Assembly** urges the County Executive Committee member in charge of Culture to;

1. Make deliberate efforts to prevent and stop the proliferation of lesbian, gay, bisexual, transgender, queer (LGBTQ) acts across all communities in the county by openly declaring it an act of indecency that has no room in human societies.
2. Initiate programs to educate young people in secondary and primary schools the health and social dangers of engaging in LGBTQ sexual acts.
3. Task the County enforcement team with ensuring compliance with the basic rules of decency in all social places within the County.
