NOTIFICATION ON SHORT TERM BORROWING.

The Deputy Speaker (Hon. Gachui Mungai): Honourable Members, I wish to make the following notification, that on March 29, 2023 the Assembly received a request from the County Executive Committee Member (CECM) in charge of Finance and Economic Planning, requesting the Assembly to permit the County Executive to enter into an arrangement with a financial institution, for the purpose of getting short term loans. The short-term loans will enable the Executive to address the delay of disbursements from the National Treasury and will be managed in accordance with Article 212 of the Constitution and Sections 58, 107, 140, 141 and 142 of the Public Finance Management Act.

Further, as required by Section 107 and 142 of the Public Finance Management (PFM) Act, the Executive shall ensure that the short-term borrowing is restricted to the management of cash flows, shall not exceed five percent of the most recent audited County Government revenue and shall be repaid within a year from the date on which it was borrowed. Additionally, the Executive shall ensure that the interest rate charged on the amount borrowed shall not exceed 1.5%.

Pursuant to the provision of Section 142 of the PFM Act that stipulates;

- 1) That the Assembly may authorize short- term borrowing by County government entities for cash management purpose only.
- 2) Any borrowing under sub-section (1) may not exceed five percent of the most recent audited revenues of the entity.
- 3) A County government that has any such borrowing shall ensure that the money borrowed is repaid within a year from the date on which it was borrowed.

I hereby commit this request to the Finance and Economic Planning Committee for consideration.
