8*. REQUEST FOR STATEMENT REGARDING GAKIRA MARKET SECURITY LIGHTS, KANGEMA AND KARUGIA TOWNS STREET LIGHTS AND MUGURU WARD HIGHMASTS

Pursuant to Standing Order 46(2) (c), I hereby request for a Statement from the Chairperson Public Works, Roads and Transport Committee on the following;

1. Is the Chairperson aware that Gakira market security lights, Kangema and Karugia Towns Street lights and Highmasts in Muguru Ward were turned off Months ago due to pending electricity bills? Is he further aware that some have been stolen and others damaged due to lack of repair and maintenance?
2. Is he aware that in the past few months there has been increased insecurity resulting to reported murders, theft of business premises among other crimes due to lack of security lights?
3. Is the Chairperson cognizant that due to the prevailing darkness, businesses have been greatly affected especially bodaboda, taxi, matatu, shops and mama mboga sectors since they are forced to close early.
4. Can the Chairperson clarify whether the County Executive has the capacity to repair, replace and maintain security lights, street lights and highmasts in the mentioned areas and measures it has put in place.
5. Can he provide information on if the County Executive is able to clear pending electricity bill for the afore mentioned areas and plans in place to ensure it is done.
6. Can the Chairperson ascertain if the County Executive has the capacity to hire an electrician in Muguru Ward for managing electricity bills, monitoring, operating, repairing and maintaining of security and street lights in the mentioned areas.
