**THE MURANG'A COUNTY SUPPLEMENTARY
APPROPRIATION BILL (No. 2), 2023.**

A Bill for

AN ACT of the Murang'a County Assembly to authorize the issue of a sum of money out of the Murang'a County Revenue Account and its application towards the service of the financial year ending 30th June, 2024 and to appropriate that sum and a sum voted on account by the Murang'a County Assembly for certain public services and purposes

ENACTED by the County Assembly of Murang'a, as follows—

Short title

1. This Act may be cited as the Murang'a County Supplementary Appropriation Act, 2023.

Issue of KSh. 350,604,379 of the County Revenue Account for service of the financial year ending 30th June, 2024 and appropriation of the money granted

2. The County Treasury may issue the sum of **Kenya Shillings Three Hundred and Fifty Million, Six Hundred and Four Thousand, Three Hundred and Seventy-Nine only** out of the County Revenue Account and apply towards the supply granted for the service of the year ending on the 30th June, 2024 .

Appropriation of the money granted

3. The sum granted by section 2 shall be appropriated for the several services and purposes specified in the second column of the First Schedule, in the amounts specified in the third column of that Schedule.

Increase of KSh. 794,391,425

4. The supply granted for the services of the year ending on 30th June, 2024 in respect of votes R-01, R-02, R-03, R-05, R-06, R-07, R-08, R-09, R-10, R-11, R-12, R-13, R-14, D-03, D-04, D-05, D-06, D-07, D-08, D-09, D-10, D-11, D-12 and D-14 in accordance with the Murang'a County Appropriation Act, 2023, is increased by the amounts specified in the third column of the First Schedule.

Reduction of 1,144,995,804

5. The supply granted for the services of the year ending on 30th June, 2024 in respect of votes R-01, R-03, R-04, R-05, R-06, R-07, R-08, R-09, R-10, R-11, R-12, R-13, R-14, D-01, D-02, D-04, D-05, D-06, D-07, D-08, D-10, D-11 and D-12 in accordance with the Murang'a County Appropriation Act, 2023, is reduced by the amounts specified in the third column of the Second Schedule.
