#### 9\* MOTION - BUDGETARY ALLOCATION FOR VILLAGE POLYTECHNICS

(Hon. Edwin Wairagu, MCA Gitugi Ward)

**AWARE** that, village polytechnics and home craft Centers are devolved functions of the County Government as per the Second schedule of the Constitution of Kenya 2010, further aware that the County Government of Murang'a has only been able to employ Sub-County Early Childhood Development Education (ECDE) officers, noting with concern that the County government of Murang'a has not been able to either employ Sub-County village polytechnic officers or Ward polytechnic officers, acknowledging that lack of these village polytechnics officers has greatly affected supervision and thus leading to poor performance and unsatisfactory service delivery;

**FRUSTRATED THAT,** the budget allocation of Kenya Shillings 13,600,000 towards polytechnics in the FY 2023-2024 was inadequate to cater for the needs of polytechnics;

**FURTHER NOTING THAT,** these polytechnics are key pillar to creation of employment to the youths and achievement of vision 2030; deeply concerned that the institutions are lagging behind in terms of infrastructure and technology due to lack of adequate finance; **this Assembly** urges the County Executive Committee Member for Education and Technical training to urgently consider improving the physical infrastructures and provide financial support to all the village

polytechnics within the County, and particularly, to ensure the allocation of at least Kenya Shillings 80,000,000 in the budget for the FY 2024-2025 towards staffing and development of polytechnics.
