AWARE, Article 29 (c) of the Constitution of Kenya 2010, states that every person has the right to freedom and security of the person, which includes the right not to be subjected to any form of violence from either public or private sources, and Article 53 (1) (d) which states that every child has a right to be protected from abuse, neglect, harmful culture practices, all forms of violence, inhuman treatment and punishment, and hazardous or exploitative labour, cognisant of the fact that sexual and gender based violence has become rampant in Murang'a

County; this Assembly urges the County Executive Members for Health and Sanitation and Finance and Planning to –

- a) Develop a comprehensive post rape care policy framework to compliment the National Government efforts in addressing rape incidents in the County.
- b) To establish a forensic laboratory for gathering and storage of DNA samples after reported rape cases
- c) To establish proper coordination and collaboration among law enforcers, hospitals and community through all inclusive sensitization, prevention and management of post rape care.
- d) Abolish fees charged to the victims for services rendered.
- e) To put in place mechanisms on engagement with National Government for establishment of specialized sexual offences unit within the investigating Police Stations in the County.
