### REVISED AMENDMENTS MURANG'A COUNTY SYMBOLS BILL NO 13 OF 2014.

## 1. CLAUSE 2

**THAT**, the Bill be amended by deleting clause 2;

# 2. CLAUSE 4

**THAT,** the Bill be amended by deleting clause 4;

### 3. CLAUSE 5

**THAT,** the Bill be amended by deleting clause 5.

### 4. CLAUSE 6

**THAT,** the Bill be amended by deleting 6.

### 5. CLAUSE 7

**THAT**, Clause 7 of the Bill be amended-

- (a) by deleting sub clause (1) of the Bill.
- (b) in subclause (2) of the Bill to be amended by inserting the word "member" immediately after the

word "Executive";

- (c) in subclause (3) to be deleted and replaced by a paragraph reading as follows;
  - "(3) Any person who shows disrespect in speech, manner or writing, to or with reference to any symbol of the county, specified likeness or specified name, or any representation thereof, shall be guilty of an offence and shall be liable to a fine not exceeding two hundred thousand shillings or to imprisonment for a term not exceeding six months or to both."
- (d) by deleting subclause (10) of the Bill.

### 6. CLAUSE 9.

**THAT**, Clause 9 be amended by deleting the words "or to both such fine and such imprisonment" immediately after the word "months."

# 7. CLAUSE 10

**THAT**, Clause 10 of the Bill be deleted and replaced with the following new clause-

Power to make

Regulations

10. The County Executive Member may by notice in the Gazette and with approval of the County Assembly, amend the Schedule to this Act.

### 8. CLAUSE 11;

THAT, a new clause 11 be inserted as -

Regulations

- 11. The County Executive Member may make regulations with approval of County Assembly-
- (1) prescribing the occasions upon which, the persons by whom and the manner in which the County Flag may be flown and displayed, as the case may be;
- (2) prohibiting, controlling or restricting the use of any specified emblem, specified likeness or specified name; and
- (3) regulating the manner in which any application may be made to the County Executive Member for permission under the Act, prescribing the form of any license by which such permission may be given and fixing any fee for such application and licence.

### 9. SCHEDULE 1.

**THAT,** Schedule 1 be amended by deleting the Schedule and replacing it with the following new schedule

### **10. CLAUSE 3**

**THAT** clause 3 of the Bill be amended by adding the following definition in alphabetical sequence;

"CEC Member" means the County Executive member in charge of county symbol
