I wish to make the following communication; pursuant to standing order 45(2) (c) which states that a member may request for a statement from the committee chairperson relating to the matters under the mandate of the committee.

This is to inform you that although statements are requested from the chair, he responds as a spokesperson of the committee which is required to investigate and compile a comprehensive report in writing. Once the response is ready, the chairperson should alert The Hon. Speaker through the Clerk, to be allocated time on the order paper by the House business committee to respond to the statement It is the responsibility of the chairperson and the committee, to ensure that any statement requested in the assembly is responded to comprehensively.

Further, following a resolution of the House Business Committee on statements, the response to statements must be issued within 14 days from the date of request and once due, the said response will be listed on the order paper.
