**AWARE**, that own revenue is one of the revenue sources for County governments besides the equitable disbursement from National Government, further aware that Article 209 (5) of the Constitution of Kenya, grants the County Governments powers to raise revenues through imposition of taxes and charges such as property taxes, entertainment taxes and any other tax authorized by enacted legislation, cognizant of the fact that this Assembly passed the Murang'a County Property Rating Bill, 2015 among other revenue Bills, recognizing the revenue potential especially in property rates which could enhance the County's local revenue target, concerned that the County Government in the current and previous financial years, has been unable to meet its local revenue targets; this Honourable House, urges the County Executive Members in charge of Finance, I.T and Planning, and Land, Housing and Physical Planning, in consultation with the County Public Service Board;

- i. To deploy revenue clerks specifically in charge of collecting property rates at the Sub County Level so as to boost the local revenue collection from properties and enhance proper record keeping of properties charged.
- ii. To ensure that all records related to revenue from Land rates are in the custody of revenue clerks under the Department of Land, Housing and Physical Planning.
