2.0 BACKGROUND

Mr. Speaker Sir, the Murang'a County Trade Licensing Bill 2015 Gazette Supplement No. 4 was published on May 04, 2015 and tabled in the Assembly on May 07,2015.

The Bill was Committed to the Committee on Trade, Insudtrialisation, Tourism and Wildlife to organise public Participation as follows:

The Committee advertised in the Daily Nation of Thursday January 28, 2016 requesting members of the public to present their views for considerations.

Public meetings were also held in various Sub-Counties as follows:

2.1 PUBLIC VIEWS

- That the under part III on Trade licensing clause 10 (3) (a & b) under requirement for license, the
 public felt that the clause should be captured in the regulations of the Act and the fine on the
 same be reduced to a reasonable amount.
- Under part III on the Trade licensing Clause 12 (2) under late application of license, members felt that the penalty for late application of the license should be specifies as 20% on the value of the trade license.
- That under part III on Trade licensing Clause 20 (2) under license to be displayed, a person who
 fails to display the license should be fined at least Kshs. 2,000 and not Kshs. 5,000 as indicated in
 the bill.
- That the regulations of the bill should capture classifications of the business and the fines require to be fined in each category of business specifies.

- Fairness in imposition of trade licenses
- Small Scale traders i.e market traders (mama mboga) should not be oppressed
- That all traders selling 2nd generation brews should never be licensed
- That "place of business" should be clear to avoid licensing of businesses near schools or residential houses
- That under section 18, the words "the chief licensing officer" Should be deleted and replaced
 thereof with the words "the licensing unit may cancel/withdraw a license..." this will avoid
 corruption and biasness in cancellation/ withdrawal of licenses.
- To ensure transparency, members proposed that part III clause 9 to be amended to read as:
 "there shall be such licensing officers in the licensing unit as shall be appointed by the county
 public service board in consultation with the executive member and with approval by the County
 Assembly".
- Clause 10 (b) to be amended to read as "in the case of an individual to fine of one thousand shillings and five thousands shillings for any subsequent similar offence within the same year.
- Part III clause 17(1) to read as a license issued under this act shall expired after duration of twelve months from the day the license/permit was granted.
- Part III Clause 2 to be amended to read as "A licensee who fails or neglects so to display the license commits an offence and shall be liable to a fine not exceeding two thousands shillings.

3.0 COMMITEE RECCOMMENDATIONS

In a sitting held on February 11, 2016 the Committee deliberated on the proposals from the public and proposed the following recommendations and amendments to the bill.

(i) In 10(3) (b) deleting the sub-clause and replacing with to read

THAT, clause 12 of the Bill be amended by-

- (i) By deleting the words "of an amount stipulated by the Executive Member" appearing immediately after the word "penalty" and replacing thereof with "of 10% the value of the Trade License.

- 8. <u>CLAUSE 18</u>

That, Clause 18 of the Bill be amended -

 18 (1) by deleting the clause "the chief licensing officer" and replaced thereof replacing with the words "the licensing unit"
