**Aware** that attaining the highest possible health standards in a manner responsive to the population needs is the core focus of the Kenya Health Sector Strategic plan, under vision 2030, and the National Government manifesto as well, further aware that this goal can only be achieved through supporting provision of equitable, affordable and quality health services at the highest attainable standards, to all Kenyans, recognizing that access to basic health care is an economic and social right, pursuant to Article 43, (1) (a) of the Constitution of Kenya, cognizant of the fact that Health Services is a devolved County function under part 2 (2) of the Fourth schedule; this Honorable assembly resolves that the County Executive Member in charge of Health and Sanitation;

- 1. Should commence the accreditation process of all health facilities in the County by the National Hospital Insurance Fund (NHIF), so as to ensure all members access NHIF benefits from whenever they are across the County.
- 2. Should conduct inspection of all health facilities in the County to establish their compliance with National Hospital Insurance Fund (NHIF) accreditation standards, in terms of vital services, personnel, infrastructure and equipment among other requirements.
- 3. Should protect the funds received from NHIF as rebates for forwarding to respective facilities, through opening of a special account for the same, to avoid misdirecting of the funds to other uses.
