#### 9. STATEMENTS (Chairperson Trade, Industries and Resource Mobilization)

I wish to respond to a request for statement by Hon. Bernard Wanyoike on the following:-

#### 1. Which markets that have been constructed or rehabilitated

In the financial year 2013/2014 Kahuro market was fenced with a perimeter stone wall and the following markets were also earmarked for rehabilitation. They include Ndunyu ya Chege, Muthithi, Maragua and Kahuro. They are awaiting award of tender.

#### 2. What plans does the CEC have for markets this financial year?

In this financial year 2014/2015 budget for markets rehabilitation and construction is Seventy Million (70M). We have proposed to rehabilitate one market per ward as per the attached schedule .This will be done on need basis and three markets have so far been selected for the first phase as follows: Kangari, Kaguku and SabaSaba markets.

#### 3. Can the CEC allocate funds for every Ward to rehabilitate the abandoned markets?

The issue of allocation of funds for every ward has been captured in the plan for rehabilitation of markets in this financial year. We therefore have one market per ward scheduled for rehabilitation as per the attached plan.

# 4. Is the CEC aware of the progress so far for establishment of Kariua Market and rehabilitation of Ngurweini market?

For Ngurwe-ini and Kariua markets there was no proposal for rehabilitation. The plan was to allocate days for open air market in both areas. This was done but the response was poor even after giving them a three months incentive of operating without paying market fees.
