SUBMISSION OF APPOINTMENT OF THE COUNTY EXECUTIVE COMMITTEE (CEC) MEMBER FOR CO-OPERATIVE DEVELOPMENT AND TRADE DEPARTMENT

Hon. Members, I wish to make the following notification; pursuant to Article 179 (2) (b) of the Constitution of Kenya, 2010, Section 8 (1) of the County Governments Act, 2012 and Section 7 (1) of the Public Appointments (County Assemblies' Approval) Act 2017, the County Secretary, through a letter Ref: MCG/PS/CONTY/ASS/VOL.II (84) dated 1st December, 2017, submitted to the County Assembly, the name of Edward Maina Muiruri as the Governor's nominee for appointment to the position of County Executive Committee Member (CECM) for the Co-operative Development and Trade Department for vetting.
