

1.2 ESTABLISHMENT AND MANDATE OF THE COMMITTEE

The Select Committee on Selection is established pursuant to provisions of Standing Order 166 and 167. Under these provisions, the Committee is mandated to:-

- 1. There shall be a select committee, to be designated Committee on Selection, consisting of the Leader of the Majority party who shall be the chairperson, the Leader of the Minority party and not less than seven and not more than ten members, who shall be nominated by Assembly parties and taking into account the interest of independent members approved by the Assembly.
- 2. The Committee on Selection shall nominate members to serve in Committees, save for the membership of the House Business Committee and Committee on Appointments.

3. The Committee on Selection shall be appointed within ten days on Assembly of a new Assembly

4. Unless otherwise provided by any written law or these standing Orders, the Committee on Selection shall in consultation with County Assembly Parties, nominate

Members who shall serve on a select Committee.

5. The Committee on Selection shall give consideration to the need for gender balance and shall, so far as may be practicable, ensure that no more than two-thirds of a committee of the County Assembly, including a committee established through a

resolution of the County Assembly shall be of the same gender.

6. A vacancy occasioned by resignation or removal of a member from a select

Committee shall be filled within fourteen days of the vacancy.

7. A member against whom an adverse recommendation has been made in a report of a select committee that has been adopted by the County Assembly shall be ineligible for

nomination as member of that committee.

LEADER OF THE MAJORITY PARTY/CHAIRPERSON COMMITTEE ON SELECTION

2.0 Background

In ensuring effective operations of County Assembly Committees the Committee on selection in accordance with its mandate, may from time to time review the membership of committees and make adjustments when necessary. The crucial mandate of the Committee in placing members in different committees is undertaken with respect to various considerations such as interest of parties, gender balance, and schedule of committee sitting time, members' resumes/Professional Career and expertise in an area.

Among some of the challenges that necessitated the need to undertake the review included some members not achieving four sittings in a week, while some members were placed in different committees sitting at the same time.

3.0 Terms of Reference for the Committee

During the review, the committee was guided by the following objectives;

- 1. To review nomination of members to sectoral and select committees in line with the Salaries and Remuneration Commission, (SRC) provision of 4 sittings per week for each member.
- 2. To align members in committee clusters such that no member will serve in two committees that are in the same cluster.
