#### 1.0 PREFACE

Hon. Speaker the Agriculture sector is a key economic component that attracts both foreign and domestic investments aimed at increasing food productivity and commercial enterprises. The Agricultural Development Support Program (ADSP) is among the grants supporting agriculture activities in Murang'a County. In fulfilling the oversight role the committee has scrutinized the ASDSP program to identify its status as at 31<sup>st</sup> December 2022 and the committee findings and recommendations are as contained in this report.

#### 2.0 INTRODUCTION

#### 2.1 Program Overview

Agriculture Sector Development Support Programme Phase Two (ASDSP II) is one of the key programmes designed by the Ministry of Agriculture, Livestock, Fisheries and Cooperatives and 47 county governments to contribute to addressing food and nutrition security and promote manufacturing. It is primarily designed to enhance the capacity of different Priority Value Chain Actors at different levels to tackle the problems that hinder commercialization of Agriculture.

The programme is implemented by the Government of Kenya (National and 47 county governments) with strong participation of the private sector as direct beneficiaries or service providers. It is financed by the Government of Kenya, Sida and EU for a period of five years (2017-2022).

#### 2.2 Program Goal and Purpose

The goal of the program is to contribute to "Transformation of crop, livestock and fishery production into commercially oriented enterprises that ensure sustainable food and nutrition security.

The purpose of the program is to develop sustainable priority value chains for improved income, employment, and food and nutrition security.

#### 2.3 Program Funding

#### The program is funded as follows;

- i. Government of Sweden 51M
- ii. GoK 12.5M
- iii. County Government 5.5M per year = 27.5M
- iv. Total project funds for 5 years = 91M

#### Funds are accessed via;

- Allocation access through activity based work plan (the process)
- ii. Grants mechanism access through extended concept for capacity building (CB) and grants innovation concepts for innovation grants mainly for women and yout

#### 2.4 ASDSP RESULT AREAS

#### a. Productivity of value chains increased

Low productivity, characterized by low production levels and irregular supply of traded commodities along the value chain, has been identified as one of the key barriers to commercialization of the agricultural sector.

In order to address this challenge, ASDSP seeks to support value chain actors (men, women and youth) in the prioritized value chains (PVCs) to increase their productivity through interventions that focus on the following areas:

- i. Enhancing the technical capacity of service providers based on identified value chain opportunities
- ii. Value Chains Innovations with high prospects for women and youth value chain actors;
- iii. Enhancing Climate Smart Agriculture and Green Growth interventions, practices and technologies

#### b. Entrepreneurial Skills Development

The Agricultural Sector Development Support Programme (ASDSP II) strengthens entrepreneurial skills of the priority value chain actors and the service providers to stimulate commercial enterprise creation. In particular, it aims to develop value chain actors and service providers in the 29 priority agricultural value chains through entrepreneurial skills development and relevant technical skills enhancement. Commercial Agricultural Value Chain Enterprises are one of the most important sources of sustainable incomes and food security. To boost sustainable incomes and food security, the programme focuses on the growth in commercial Micro – Small and Medium Enterprises (MSME) through value chain actors and service providers' entrepreneurial skills development.

#### c. Improved access to markets by priority value chain actors

We support value chain actors with "soft" market access interventions by identifying and accelerating breakthrough solutions, ideas and conversations through partners who facilite market linkages, linkages market information and financial services. Value Chain Actors are sensitized to comply with health safety and eco-standards in food production and supply chains. It is acknowledged that poor roads and lack of security, electricity, on and off-farm storage and other infrastructure services may hinder market access. These barriers fall outside the domain of the programme. However, such issues cascaded from the VCAs to the relevant authorities through the established Sector coordination structures and value chain platforms.

Efforts are geared towards strengthening value chain groups into bigger and viable entities like cooperatives, associations, companies etc. to achieve this objective, smaller entities are encouraged to merge into larger federations like Unions, cooperatives and private companies. These initiatives are pursued through the Value Chain Platforms (VCPs) at the county as well as the VCPs to be established at the regional and national levels. Existence of these VCPs is considered not only an important entry point for cost effective service delivery for improved productivity and delivery of quality products, but also provides a forum for lobbying and resolving conflicting interests of VCAs and hence Value Chain justice.

## d. Structures and capacities for consultation and coordination in the sector strengthened

ASDSP II is operating under a devolved system of government. The Agriculture sector recognized this and developed a consultation and cooperation mechanism to promote good working relationship between the two levels. However, the Agriculture sector is still faced with weak and inadequate structures and capacities for consultation, cooperation and coordination. This is one of the key problems that the programme is striving to address in order to contribute to the realization of commercialization of priority value chains. ASDSP II therefore aims at strengthening structures and capacities for consultation, cooperation and coordination in the Sector through the following:

- i. Initiatives for establishment of the structures for consultation and coordination supported
- ii. Enhancing capacities of established structures for consultation, cooperation and coordination
- iii. Enhancing participation of stakeholders in consultation and coordination structures
- iv. Facilitation of preparation of sector policies, strategies and regulations for launch and roll out

# .0 COMMITTEE RECOMMENDATIONS

#### he Committee Recommends as follows:

- a) **THAT** the community should be sensitized on the Agriculture support programs and be capacity built on the role they can undertake in execution of the programs at all levels.
- b) **THAT** there should be equity and equality in distribution of projects across the County to curb sentiments of discrimination on the side of the County Government where some wards benefit from two or more programs while others have none.
- c) THAT the CECM in charge of Agriculture should in future ensure proper dissemination of information regarding programmes that require the participation of members of public so that the deserving and interested groups are not left out from such programmes.
- d) THAT in future the CECM In charge of Agriculture should ensure full involvement of elected Members of the County Assembly in launching of various programmes in the ward
- e) **THAT,** The CECM Finance should ensure timely disbursement of counterpart fund as per the operational agreement between County Government and National Government so as not to compromise on the implementation of ASDSP.
- f) THAT, The County Government should ensure that relevant and regular reports on the ASDSP projects are submitted to the county Assembly Committee of Agriculture and provided to the relevant stakeholders detailing the relevance of the project, level of achievement of the projects, impact and sustainability among other items.
- g) The ASDSP cow milk program should be integrated with the county government milk subsidy program so as to maximize returns in the dairy sector.
