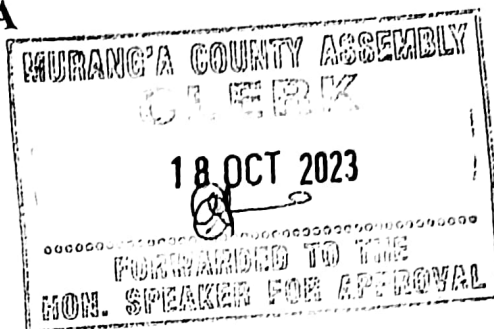

EXECUTIVE SUMMARY

Pursuant to Section 14 (2) (c) of the Urban Areas and Cities (Amendment) Act 2019, and Section 6 of the Public Appointments (County Assemblies Approval) Act No. 5 of 2017, the underlisted persons were nominated to be board members of the Kenol Municipal Board;

- a) Robert Kimani Ndung'u
- b) Charles Kabuga Githatu
- c) John Gathuma Gichuhi
- d) Patrick Kamande Ndorongo
- e) Rosemary Ngigi

The Hon. Speaker on Tuesday, October 10, 2023 at 9.30 am informed the House that he had received communication from the County Secretary on the nomination of persons for appointment to the Kenol Municipal Board. He then referred the notification to the relevant Committee on Land, Housing, and Physical Planning for vetting and reporting to the House within 21 days from the date on which the committee first sat to consider the nomination as pursuant to section 9 (1) of the Public Appointments (County Assemblies Approval) Act, 2017.

Upon committal of the notification, the committee held a sitting on Wednesday October 11, 2023 at 2.00 p.m. in the County Assembly to adopt the workplan of the vetting and to scrutinize the nominee CV and testimonials forwarded along with the letter from the County Secretary.

Mr. Robert Kimani Ndung'u has been nominated as a representative of the professionals' associations representing Kenol Municipality as per Section 14 (3) (a) of the Urban Areas and Cities (Amendment) Act UAC(A) 2019 secondly,

Mr. Charles Kabuga Githatu has been nominated as a representative of the private sector in Kenol municipality as per Section 14 (3) (b) in addition to this Mr. Patrick Kamande Ndorongo has been nominated as a representative of the registered associations of the informal sector in the area; lastly Rosemary Ngigi has been nominated under Section 14 (2) (b)

Pursuant to section 7 (4) and (5) of the Public Appointments (County Assemblies Approval) Act, 2017, the Clerk of the County Assembly placed an advertisement in the print media on Wednesday October 11, 2023 page 6 of the Standard newspaper and on page 21 in the Daily Nation inviting members of the public to attend the hearing and/or submit memoranda by way of written statements on oath (sworn affidavits) on the suitability or otherwise of the nominee. The Committee confirmed that by Tuesday October 17, 2023 at 8.00 a.m. the Office of the Clerk had received 2 sworn affidavits by *Antony Ndegwa Kariuki*; and **Festus Ngugi**.

The nominees appeared before the committee on Tuesday October 18, 2023 from 8.30 am. for approval hearing on their suitability or otherwise for appointment as board members, in accordance with section (7) and (8) of the Public Appointments (County Assemblies Approval) Act, 2017. The committee observed that the nominees exhibited outstanding credentials, experience and competencies in relation to the position they have been nominated to.

Having conducted the vetting of the nominees as pursuant to Section 14 (2) (c) of the Urban Areas and Cities (Amendment) Act 2019 and section (7) and (8) of the Public Appointments (County Assemblies Approval) Act, 2017, **the Committee hereby RECOMMENDS**;



1.3 Committee mandate

The Departmental Committee on Land, Housing and Physical Planning is established pursuant to provisions of Standing Order 195 (5). Under these provisions, the Committee is mandated to: -

- a) Investigate, inquire into, and report on all matters relating to the mandate, management, activities, administration, operations and estimates of the assigned departments;
- b) Study the programme and policy objectives of departments and the effectiveness of the implementation;
- c) Study and review all county legislation referred to it;
- d) Study, assess and analyse the relative success of the departments as measured by the results obtained as compared with their stated objectives;
- e) Investigate and inquire into all matters relating to the assigned departments as they may deem necessary, and as may be referred to them by the Assembly;
- f) To vet and report on all appointments where the Constitution or any law requires the Assembly to approve, except those under Standing Order 189 (*Committee on Appointments*); and
- g) Make reports and recommendations to the Assembly as often as possible, including recommendation of proposed legislation.

Pursuant to Standing Order 204 Second Schedule the Committee on Land, Housing and Physical Planning is mandated to deal with all matters related to Land surveying and Mapping, housing, boundaries and fencing.

1.4 Terms of Reference

The Committee was guided by the following objectives;

- a. To conduct the approval hearing of the nominees for appointment to the Murang'a Municipal Board
- b. To report on observations of the vetting of the nominees and their suitability for appointment as a Board Members.
- c. To recommend the approval or rejection of the nominees.

2.0 BACKGROUND

2.1 Communication from the County Secretary

Pursuant to Section 14 (2) (c) and 3 (c) and (d) of the Urban Areas and Cities (Amendment) Act 2019, and Section 6 of the Public Appointments (County Assemblies Approval) Act No. 5 of 2017, the County Secretary in a letter dated

May 11, 2023 vide Ref: MCG/ADM/CS/5 (56)

notified the Clerk of the County Assembly names of the nominees for vetting and approval by the County Assembly for the position of board member of the Kenol Municipal Board as highlighted below:

2.2 Committal of Notification of Nomination

During a sitting of the County Assembly held on Wednesday, October 11, 2023 at 9.30 a.m. the Hon. Speaker through a communication from the Chair informed the House that the office of the Clerk had received a notification from the County Secretary on the nomination of board members to the Kenol Municipal Board.

He then referred the notification, Curricula Vitae and testimonials of both individuals to the Committee on Lands, Housing and Physical Planning, who are to undertake vetting of the nominees and report back to the House within 21 days from the date the Committee first sits to consider the nomination of the individuals as per Section 9 (1) of the Public Appointments (County Assemblies Approval) Act, 2017.

2.3 Pre-Vetting Committee Sitings

The committee held a sitting on Wednesday, October 11, 2023 at 2.00 p.m. in the County Assembly, to deliberate and adopt the work plan of the vetting process and to scrutinize the submitted curricula vitae, testimonials and clearance requirements of both nominees, as a preliminary observation of their suitability for appointment.

3.0 LEGAL ANALYSIS OF THE ISSUES FOR CONSIDERATION IN VETTING

3.1 Issues for Consideration

The Committee observed that the issues for consideration in relation to the nomination and approval exercise are provided for in Section 8 of the Public Appointments (County Assemblies Approval) Act as follows –

- (a) the procedure used to arrive at the nominees;
- (b) the constitutional and statutory requirements relating to the office in question; and
- (c) the suitability of the nominee for the appointment proposed, having regard to whether the nominees' credentials, abilities, experience and qualities, meet the needs of the body to which the nomination is being made.

(a) Suitability of Nominee

In conducting the vetting process, the committee observed that the suitability of the nominees shall be evaluated holistically based on the following criteria amongst others as set out in section 7 (8), (10) and (11), Section 8 and Section 9 of the Public Appointments (County Assemblies Approval) Act and the Constitution of Kenya, 2010.

- i. Academic credentials
- ii. Professional training, experience and employment record
- iii. Potential conflict of Interest
- iv. Statutory Obligations
- v. Vision, Leadership and knowledge of the sector
- vi. Integrity
- vii. Expectations and Key Priorities
- viii. Performance and presentation during the interview
- ix. Overall suitability

(b) Leadership and Integrity

The Committee, in determining the suitability of the nominees, took into consideration the provisions on leadership and integrity as outlined under Chapter Six of the Constitution in particular, the Committee took cognizance of following provisions -

Article 73 (2) of the Constitution which provides that the guiding principles of leadership and integrity include: -

- (a) selection on basis of personal integrity, competence and suitability, or election in free and fair elections;*
- (b) objectivity and impartiality in decision making, and in ensuring that decisions are not influenced by nepotism, favoritism, and other improper motives or corrupt practices;*
- (c) selfless service based solely on the public interest, demonstrated by-*
 - (i) honesty in the execution of public duties; and*
 - (ii) the declaration of any personal interest that may conflict with public duties;*
- (d) accountability to the public for decisions and actions; and*
- (e) discipline and commitment in service to the people.*

The Committee was satisfied that the nominees complied with the constitutional provisions on leadership and integrity and that all legal and constitutional provisions of the vetting process were observed.

(c) Clearance Requirements

Prior to the hearing, the Committee resolved that the nominee be asked to submit his original academic certificates and clearance documents from the following institutions for the vetting exercise which it verified against the originals;

- a) Kenya Revenue Authority (KRA)
- b) Directorate of Criminal Investigations (DCI)
- c) Higher Education Loans Board (HELB)
- d) Credit Reference Bureau (CRB)

Clearance by the foregoing institutions was primarily meant to provide information about the nominees on: -

- a) Matters touching on integrity;
- b) Tax compliance;
- c) Loan repayments; and
- d) Presence or absence of criminal records.

Members of the committee observed that the issues for consideration in relation to the nominations and approval exercise are provided for in Section 8 of the Public Appointments (County Assembly Approval) Act as follows –

- (d) the procedure used to arrive at the nominee;*
- (e) the constitutional and statutory requirements relating to the office in question; and*
- (f) the suitability of the nominee for the appointment proposed having regard to whether the nominee's credentials, abilities, experience and qualities, meet the needs of the body to which the nomination is being made.*

The Committee was satisfied at the competitive process used to arrive at the nominees, and that constitutional requirements were met when selecting the nominees by the appointing authority in addition, the Committee observed the provisions of Section 14 of the Urban Areas and Cities Act No. 13 of 2011, and members were satisfied that the county executive complied with the provisions of Section 13 thirdly, the Committee noted that the face of the county was well represented, including representation on gender lastly, were satisfied that the nominee's credentials, abilities and vast experiences in their respective careers made them suitable to serve as board members to the Kenol Municipality.

3.2 Memoranda from the Public in respect of the nominee

Section 7 (10) of the Public Appointments (County Assembly Approvals) Act, provides *that any person may, prior to the approval hearing, and by written statement on oath, provide the Clerk with evidence contesting the suitability of a candidate to hold office to which the candidate has been nominated.*

The Clerk of the Assembly placed an advert in the print media on October 11, 2023 in both the Standard and Nation newspapers inviting members of the public to submit written memoranda by way of written statements on oath (affidavits) on the suitability or otherwise of the nominees in conformity with Section 7 (10) of the Public Appointments (County Assembly Approvals) Act, 2017.

In this regard, as at Tuesday October, 17, 2023 at 8.00 am, the Committee had received the following memoranda;

3.2.1 Affidavit by *Antony Ndegwa Kariuki*;

Mr. Antony Ndegwa Kariuki, a businessman based in Kenol Town averred that;

- (a) Rev Captain Patrick Kamande Ndorongo and John Gathuma Gichuhi are men of clothe who had no "business other than ministers of the Gospel"

- (b) That Rev Captain Kamande Ndorongo is currently posted outside the proposed municipality.
- (c) That Kenol town had more enough professionals who should have been nominated.
- (d) The process of nominating the proposed members as ‘unprocedural’ as per the requirements of the Urban Areas and Cities Act.

Observation.

The Committee observed that the accretion that “men of clothe” had no legal bearing as the same were not barred from holding public office if given a chance in addition, members of the committee were satisfied that Rev. Captain Patrick Kamande Ndorongo not only runs a business of a motor bike spares shop but was also a resident of Kenol town with other vested commercial interests in the town. Lastly the Committee also noted that the procedure outlined in Section 13 and 14 of the Urban Areas and Cities (Amendment) Act was followed.

3.2.2. Affidavit by *Festus Ngugi*;

Mr Festus Ngugi, a businessman within Kenol town averred that;

- (a) The nominees were strangers who had been imposed on the residents of Kenol.
- (b) That the nominee Bernard Mwangi Mugo is not a resident of Kenol and that the nature of his employment may have him transferred to a different location at any time.
- (c) That Rosemary Muthoni Ngigi is a retired teacher with no experience on the running of a Municipality Board.

1.7 APPROVAL HEARING OF MR JOHN GATHUMA GICHUHI – KENOL MUNICIPAL BOARD MEMBER NOMINEE

Mr. John Gathuma Gichuhi, of National Identification Card Number 13275509, the nominee for Kenol Municipal Board, appeared before the Committee on Tuesday 17th October, 2023 at 9:00 a.m and was cross examined under oath pursuant to Article 195 of the Constitution. The approval hearing commenced as per the Public Appointments (County Assemblies Approval) Act, 2017.

The nominee presented as follows, both orally and in writing: -

1. He is a Kenyan citizen born on 11th November, 1972 in Murang'a County and resides in Murang'a.

The approval hearing commenced as per the Public Appointments (County Assemblies Approval) Act, 2017.
